### PH-1 Conditional Use Permit CUP2017-09

235 West Maple Avenue - Applicant, Wingwalker Brewing, LLC (David Robkin)

**Request:** Allow a microbrewery in an existing industrial building that will manufacture specialty beer and offer beer sampling within a tasting room that will be open to the public. This property is located in the M (Manufacturing) zone. Determine that the project is Categorically Exempt (Class 1) from the California Environmental Quality Act (CEQA).

### PH-2 Conditional Use Permit CUP2017-08 and Minor Exception ME2017-16 609 West Olive Avenue – Applicant, Minghua Na

**Request:** Construct a new, detached 1,607 square foot, two-story unit behind an existing single-story home. Applicant is also requesting a Minor Exception from Monrovia Municipal Code Section 17.24.030 to allow two (2) open parking spaces and two (2) garage spaces in lieu of the required four (4) garage parking spaces. The subject property is located in the RM 3500 (Residential Medium Density) zone. Determine that the project is Categorically Exempt (Class 3) from the California Environmental Quality Act (CEQA).

Recommendation: Approve Conditional Use Permit CUP2017-08 and Minor Exception ME2017-16
