A. MINUTES FOR APPROVAL

Motion to approve the Minutes of the August 17 and September 21, 2017, meetings.

C. FOLLOW-UP ITEMS

1. Req. #2015-188: Gold Line – Mayflower and Central Aves

2. Mayflower Ave and Huntington Dr

Preliminary plans were discussed at the December 17, 2015, meeting. Intersection is currently being evaluated by Gibson Transportation Consulting, Inc. for the re-adjustment of lane lines. Committee to review signal timing.

3. Req. #2016-026: North and South Mayflower Ave (from Huntington Dr) – Safety

Resident requesting to refresh street striping on north and south Mayflower from Huntington and/or to add raised pavement markers. Intersection is currently being evaluated by Gibson Transportation Consulting, Inc. for the re-adjustment of lane lines. *Cross-referenced with Req. #2015-188).*

4. Req. #2016-065: California and Lemon Aves – Safety (signage)

Resident requesting a four-way Stop controlled intersection on California at Lemon. Current two-way Stop controlled intersection on Lemon (east / west traffic). The Police Department records indicate that seven collisions have occurred as of January 2016. Of the seven collisions, six were non-injury and one was a hit and run investigation. There were two Police Reports taken of the seven incidents. Cross Traffic Does Not Stop (east / west traffic) signage installed, 25 linear feet of red curbing installed on the eastside of California north and south of Lemon, along with the refreshing the intersection striping. Brush clearance completed on the southwest corner. Letter mailed on Wednesday, August 16, 2017, providing the resident with a traffic calming update with an ongoing six month evaluation period. To be re-evaluated in the fall, 2017.

5. **Req. #2017-001: Bradbury Rd speed cushions – Speeding / Traffic**
Resident requesting the removal of the Bradbury speed cushions, installed in December 2015, in response to the letter received as to the installation. *Cross-reference with Req. #2017-034.*
6. **Req. #2017-005: 620 Linwood Ave – Traffic / NO PARKING (red curb)**
Resident requesting red curb at driveway apron. Trash receptacles are being moved onto the lawn to allow for street parking. Staff conducted a site evaluation. There is very limited residential parking. Letter mailed on Wednesday, August 16, 2017, notifying the resident of the site evaluation results and upcoming street renewal. To be re-evaluated in the fall, 2017.
7. **Req. #2017-008: Parkrose Ave at Bradoaks Elementary School – Traffic**
Resident requesting additional Police patrol to monitor traffic violators; NO U-TURN and parking in striped red curb zone during school drop-off and pick-up hours. Police Department to provide visual presence and monitor traffic. Location is currently being evaluated by Gibson Transportation Consulting, Inc.
8. **Req. #2017-012: Almond Ave – Speeding / Traffic / Safety**
Resident requesting data box speed study. Police Department to conduct a data box speed study.
9. **Req. #2017-013: Bradoaks and Greystone Aves – Traffic / Safety**
Resident requesting speed cushions to prevent traffic from failing to stop and rolling through the intersection. Work Order placed to refresh striping and replace Stop signage.
10. **Req. #2017-014: Mountain Ave (north of Lemon) – Traffic / Safety / NO PARKING (red curb)**
Resident requesting red curbing on the east side of Mountain, north of Lemon, prior to the northbound traffic lanes merging to the left. Temporary NO PARKING to be posted. Letter to be sent notifying the residents of the temporary NO PARKING and the potential 90' of red curbing. *Cross-referenced with Req. #2016-014, Req. #2016-044, and Req. #2016-47.*
11. **Req. #2017-015: 714 North Norumbega Dr – Speeding / Traffic / Safety**
Resident requesting a data box speed study and speed cushions on N Norumbega due to speeding. Police Department to conduct a data box speed study.
12. **Req. #2017-016: Mayflower and Evergreen / Diamond intersection – Safety (crosswalks and sidewalks)**
Resident requesting 4-way crosswalks and wrap-around sidewalks; currently blocked by an Edison power pole, and to allow for pedestrian traffic. *Cross-referenced with #2017-032.*
13. **Req. #2017-019: Shady Oaks Dr and North Canyon Blvd – Safety (signage)**
Resident requesting three-way Stop controlled T-intersection at Shady Oaks and Canyon. Current one-way Stop controlled intersection on Shady Oaks. Work Order placed for northeast corner brush clearance.
14. **Req. #2017-022: 120 West Cypress Ave – Speeding / Traffic / Safety**
Resident requesting traffic calming and a data box speed study on W Cypress due to speeding. Police Department to conduct a data box speed study.

15. **Req. #2017-024: 140 North Heliotrope Ave – Blue ADA Curb**
Resident requesting a blue ADA curb in front of residence. Staff to conduct a second on-site evaluation.
16. **Req. #2017-025: 100 East Evergreen Ave alleyway – Traffic**
Resident requesting traffic calming in the alleyway due to excessive traffic during peak hours due to the Gold Line intersections.
17. **Req. #2017-026: Alta Vista and Chestnut Aves – Safety (signage)**
Resident requesting a 4-way Stop controlled intersection; currently a 2-way (east / west) intersection. The Police Department records indicate that six collisions have occurred as of June 2016. Of the six collisions, four were non-injury and two were injury. *Cross-referenced with #2017-035.*
18. **Req. #2017-028: 700 – 800 blocks of Wildrose, Oakdale, and Lime Aves – NO PARKING**
Resident requesting enforcement of NO PARKING on the 700 – 800 blocks of Wildrose, Oakdale, and Lime. Staff to conduct an on-site evaluation of current signage to determine if hours need to be adjusted.
19. **Req. #2017-029: 329 Linwood Ave alleyway – NO PARKING (signage)**
Resident requesting NO PARKING signage in the alleyway where his garage is located. Vehicles have been parked in the alleyway and block his garage.
20. **Req. #2017-030: Duarte Rd (between Eighth and Encino Aves) – Safety / Parking**
Resident concerned with east / west traffic blind spots on Duarte, as residents exit their driveways, due to the parked vehicles and rolling trash bins.
21. **Req. #2017-031: Pomona and Primrose Aves – Parking**
Police Department concerned with the overflow of parked vehicles and no time limit on Pomona and Primrose due to the current Gold Line parking structure fees being implemented. Vehicles are parking into the crosswalk and corner ADA ramps.
22. **Req. #2017-032: Mayflower and Evergreen / Diamond intersection – Safety**
Resident requesting a light signal intersection due to traffic violators not adhering to the current 4-way Stop controlled intersection. *Cross-referenced with #2017-016.*
23. **Req. #2017-033: 838 Oakdale Ave – Speeding / Traffic / Safety**
Resident requesting a data box speed study. Police Department to conduct a data box speed study. *Cross-referenced with #2016-062 (closed).*
24. **Req. #2017-034: Bradbury Rd speed cushions (south of Lemon Ave) – Speeding**
Resident requesting the installation of speed cushions on Bradbury; south of Lemon. *Cross-referenced with Req. # 2017-001.*
25. **Req. #2017-035: Alta Vista and Chestnut Aves – Safety (signage)**
Business owner requesting a 4-way Stop controlled intersection; currently a 2-way (east / west) intersection. The Police Department records indicate that six collisions have occurred as of June 2016. Of the six collisions, four were non-injury and two were injury. *Cross-referenced with #2017-026.*
26. **Req. #2017-036: 1601 Radford Pl – Traffic / NO PARKING (red curb)**
Resident requesting red curbing, between two driveways, which is unable to accommodate a standard-sized parked car. Parked cars impede both driveways.

27. Req. #2017-037: Magnolia and Palm Aves – Safety (signage)

Resident requesting a 4-way Stop controlled intersection at Magnolia and Palm; currently a 2-way (east / west) intersection.

28. Req. #2017-038: Fifth Ave (between Chestnut and Olive Aves) – Speeding / Traffic / Safety

Resident requesting a data box speed study. The Police Department conducted a data box speed study on Fifth Avenue (north of Chestnut) on Wednesday, September 20 through Tuesday, October 3, 2017. The data box is small, mounted to a City street light pole and not meant to be visible to drivers so that it will collect accurate information. The data box statistics indicate that 42,918 vehicles were tracked. The 85th percentile of speed driven is 33 mph with the overall average speed of 28.3 mph driven. The posted speed limit is 35 mph. Based upon the statistics gathered, the flow of traffic is consistent with the posted speed.

29. Req. #2017-039: Mayflower and Olive Aves (Monroe Elementary) – Traffic / Safety

1. Resident requesting a 4-way Stop controlled intersection at Mayflower and Olive; currently 2-way (east / west) intersection.
2. Resident requesting blue ADA curb / parking at the Mayflower and Olive intersection, at Monroe Elementary.

30. Req. #2017-040: Myrtle Ave (eastside) at East Cherry Ave – Safety / NO PARKING (red curb)

Resident requesting additional red curbing on the eastside of Myrtle at Cherry. Unable to see on-coming traffic when turning left, onto Myrtle, from Cherry.

31. Req. #2017-041: 200 block of West Evergreen – Speeding / Traffic / Safety

Resident requesting a data box speed study. The Police Department conducted a data box speed study from Tuesday, September 12, 2017, through Tuesday, September 21, 2017. The data box statistics indicate that 79,439 vehicles were tracked. The 85th percentile of speed driven is 28.61 mph with the overall average speed of 21.42 mph driven. The highest speed tracked, of one vehicle, was 54 mph. It is unknown if this vehicle was a first responder. The posted speed limit is 35 mph. Based upon the statistics gathered, the flow of traffic is consistent with the posted speed. *Cross-reference with Req. #2016-054 (closed).*

32. Req. #2017-042: 135 West Cherry Ave – Blue ADA Curb

Resident requesting a blue ADA curb in front of residence. Staff to conduct an on-site evaluation.

33. Req. #2017-043: 720 and 730 East Cypress Ave – Traffic / NO PARKING (red curb)

Pink Transfer, Inc. is requesting red curbing, between two driveways in front of their business, to allow the large semi-trucks to enter and exit the driveways safely. The space is only able to accommodate one parked vehicle. Currently orange cones are being used to provide extra spacing. The two driveways are also parallel to the carpet business across the street that also have large semi-trucks for delivery.

D. AGENDA ITEMS

1. Req. #2017-044: 1710 South Mayflower Ave – Traffic / NO PARKING (red curb)

Resident requesting short red curbing, on both sides of the driveway, to prevent vehicles from parking up the driveway apron and blocking the line-of-sight of on-coming vehicles.

2. **Req. #2017-045: Canyon Blvd and Lime Ave Intersection – Traffic / Safety**
Resident requesting a 4-way Stop controlled intersection, or crosswalks, at Canyon and Lime; currently 2-way (east / west) intersection.
3. **Req. #2017-046: 120 El Nido Ave – Speeding / Traffic / Safety**
Resident requesting a data box speed study, speed cushions, and enforcement of the NO LEFT TURN from Hillcrest.
4. **Req. #2017-047: 600 block of West Olive Ave – Parking**
Resident requesting the evaluation of limited street parking due to street sweeping and trash pick-up days.
5. **Req. #2017-048: 311 S California – Speeding**
Resident requesting a data box speed study and speed cushions, on California at Palm, due to excessive speeding in a school zone.
