**CONVENE:** Mayor Pro Tem Gloria Crudgington convened the Regular Meeting of the Monrovia City Council on Tuesday, November 21, 2017, at 7:33p.m. in City Council Chambers, in honor of Shane Orcutt, born on November 16, 2017, to Brett and Alysha Orcutt.
