MATTERS ON THE AGENDA: If you wish to address the Planning Commission on a matter on the agenda, please wait until the Chair opens the public hearing or calls for public comment on that matter. For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

AGENDA ITEMS: The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

PH-1 [Conditional Use Permit CUP2018-01](#)
1216 Royal Oaks Drive – Applicant, Santa Teresita, Inc.

Request: Construct a new two-story, 28-bed assisted living facility (Assisted Living Cottage #2) approximately 20,810 square feet in floor area as outlined in the Rose Gardens at Santa Teresita (RGST) Specific Plan. A Program Environmental Impact Report (Program EIR) was certified on June 14, 2011 (State Clearing House No. 2010091021) by the City of Duarte. Determine that the project is consistent with the Program EIR, and pursuant to the Public Resources Code 21083.3 and CEQA Guidelines sections 15162, 15168, and 15183 is exempt from the requirement that additional environmental documentation be prepared.

410 South 5th Avenue – Applicants, Wang Feng and Chen Xiaomin

Request: Construct two new detached residential units resulting in a two-story second dwelling behind a main dwelling in the RM2500 (Residential Medium) zone. Determine that the project is Categorically Exempt (Class 3) from the California Environmental Quality Act (CEQA).
