### AR-1 DPR 2018-01; 448 Linwood Avenue, Jane Wu Architect, Inc., Applicant

Teresa Santilena gave the staff report. There was a question about what was original on the front elevation. The windows are original but the door and front step are not. The applicant said that their addition will follow the same architectural style and they believe the house will look better than it does now.

The Commission discussed the item and the consensus was that the neighborhood had been changed so much that it would not be eligible to be a historic district.
