## C. FOLLOW-UP ITEMS

# 1. Req. #2015-188: Gold Line – Mayflower and Central Aves – Safety

# 2. Mayflower Ave and Huntington Dr

Preliminary plans were discussed at the December 17, 2015, meeting. Intersection is currently being evaluated by Gibson Transportation Consulting, Inc. for the readjustment of lane lines. Committee to review signal timing. DO NOT BLOCK INTERSECTION signage installed on November 16, 2017, for north and southbound traffic.

# 2. Reg. #2016-026: North and South Mayflower Ave (from Huntington Dr) - Safety

Resident requesting to refresh street striping on north and south Mayflower from Huntington and/or to add raised pavement markers. Intersection is currently being evaluated by Gibson Transportation Consulting, Inc. for the re-adjustment of lane lines. DO NOT BLOCK INTERSECTION signage installed on November 16, 2017, for north and southbound traffic. *Cross-referenced with Req. #2015-188 and Req. #2017-054.* 

## 3. Req. #2017-008: Parkrose Ave at Bradoaks Elementary School – Traffic

Resident requesting additional Police patrol to monitor traffic violators, NO U-TURN and parking in stripped red curb zone during school drop-off and pick-up hours. Location is currently being evaluated by Gibson Transportation Consulting, Inc. New signage installed on Thursday, November 16, 2017: seven regarding parking, two Stop, and one NO U-TURN.

## 4. Req. #2017-039: Mayflower and Olive Aves (Monroe Elementary) - Traffic / Safety

- 1. Resident requesting a 4-way Stop controlled intersection at Mayflower and Olive; currently 2-way (east / west) intersection.
- 2. Resident requesting blue ADA curb / parking at the Mayflower and Olive intersection, at Monroe Elementary.

Current blue ADA curb on the north-west corner of Alta Vista and Olive.

Olive Avenue (north side) signage indicates:

- No Left Turn or U-turn from 7 9 a.m. and 2 3 p.m.
  - Wednesday 7 9 a.m. and 12 1 p.m.
  - Except Sat. Sun. and Holidays
- Teacher parking only 7 a.m. 3 p.m. Monday Friday
  - Except Sat. Sun. and Holidays

# Req. #2017-047: 600 block of West Olive Ave (north side) – Speeding / Traffic / Parking

Resident requesting a speed study and the evaluation of limited street parking due to street sweeping and trash pick-up days. The Police Department conducted the following data-trailer speed studies:

Wednesday, December 13 through Tuesday, December 19, 2017. The statistics indicate that 2,917 vehicles were tracked westbound. The 85<sup>th</sup> percentile of speed driven was 34 mph with the overall average speed of 27.5 mph driven.

Wednesday, March 14 through Tuesday, March 20, 2018. The statistics indicate that 3,610 vehicles were tracked eastbound. The 85<sup>th</sup> percentile of speed driven was 25.33 mph with the overall speed of 19.77 mph driven.

Wednesday, June 6 through Tuesday, June 12, 2018. The statistics indicate that 2,728 vehicles were tracked eastbound. The 85<sup>th</sup> percentile of speed driven was 25.85 mph with the overall average speed of 19.25 mph driven.

Wednesday, June 13 through Tuesday, June 19, 2018. The statistics indicate that 1,519 vehicles were tracked westbound. The 85<sup>th</sup> percentile of speed driven was 24.94 mph with the overall average speed of 19.48 mph. The posted speed limit is 25 mph.

NO PARKING (street sweeping) signage adjusted on the north and south sides of W Olive, at Lucinda Garcia Park.

# 6. Req. #2017-050: 103 East Altern Ave (at Peck Rd) – Speeding / Traffic / Safety (red curbing)

Resident requesting a speed study due to excessive speeding, on Peck at Altern, and red curbing at the north side of the driveway apron, for line-of-site traffic safety. The Police Department conducted the following data-trailer speed studies:

Wednesday, December 27, 2017 through Tuesday, January 2, 2018. The statistics indicate that 6,828 vehicles were tracked southbound. The 85<sup>th</sup> percentile of speed driven was 34.39 mph with the overall average speed of 27.17 mph driven.

Wednesday, February 14 through Tuesday, February 20, 2018. The statistics indicate that 6,388 vehicles were tracked northbound. The 85<sup>th</sup> percentile of speed driven was 36.16 mph with the overall average speed of 31.17 mph driven.

Wednesday, April 25 through Thursday, May 3, 2018. The statistics indicate that 11,728 vehicles were tracked north and southbound. The 85<sup>th</sup> percentile of speed driven was 39 mph with the overage average speed of 32.8 mph driven.

Friday, May 18 through Saturday, May 26, 2018. The statistics indicate that 14,118 vehicles were tracked north and southbound. The 85<sup>th</sup> percentile of speed driven was 39 mph with the overall average speed of 34.1 mph driven.

Wednesday, June 20 through Tuesday, June 26, 2018. The statistics indicate that 11,877 vehicles were tracked northbound. The 85<sup>th</sup> percentile of speed driven was 32.95 mph with the overall average speed of 24.56 mph driven.

Thursday, July 12 through Wednesday, July 18, 2018. The statistics indicate that 9,946 vehicles were tracked southbound. The 85<sup>th</sup> percentile of speed driven was 35.1 mph with the overall average speed of 27.86 mph driven. The posted speed limit is 35 mph.

The Police Department's records indicate the following collision history, on Peck between Duarte and Camino Real:

2018 0 collisions

On Monday, June 13, 2018, six feet of red curbing was added to the north side of the driveway apron and the existing red curb on the south side was extended and refreshed.

# 7. Req. #2017-053: North Canyon Blvd (north of Foothill Blvd) – Speeding / Traffic / Safety

Resident requesting a speed study and speed cushions on N Canyon. Police Department to conduct a data-trailer speed study, provide visual presence, and to monitor the traffic. *Cross-referenced with Req. #2017-010 – Closed.* The Police Department conducted the following data-trailer speed studies:

Wednesday, December 20 through Tuesday, December 26, 2017. The statistics indicate that 15,373 vehicles were tracked southbound. The 85<sup>th</sup> percentile of speed driven was 33.74 mph with the overall average speed of 28.59 mph driven.

Tuesday, December 26, 2017 through Monday, January 1, 2018. The statistics indicate that 16,984 vehicles were tracked northbound. The 85<sup>th</sup> percentile of speed driven was 36 mph with the overall average speed of 31.7 mph driven.

Wednesday, March 21 through Tuesday, March 27, 2018. The statistics indicate that 19,551 vehicles were tracked southbound. The 85<sup>th</sup> percentile of speed driven was 33.61 mph with the overall average speed of 28.5 mph driven.

Wednesday, April 18 through Tuesday, April 24, 2018. The statistics indicate that 14,633 vehicles were tracked northbound. The 85<sup>th</sup> percentile of speed driven was 30.37 mph with the overall average speed of 23.82 mph driven. The posted speed limit is 25 mph.

# 8. Req. #2018-002: 219 West Olive Ave – Speeding / Traffic / Safety

Resident requesting a speed study, speed cushions, and traffic calming on W Olive, due to excessive speeding. The Police Department conducted the following data-trailer speed studies:

Tuesday, January 16 through Monday, January 22, 2018. The statistics indicate that 5,727 vehicles were tracked both east and westbound. The 85<sup>th</sup> percentile of speed driven was 34 mph with the overall average speed of 28.8 mph driven.

Friday, June 1 through Thursday, June 7, 2018. The statistics indicate that 4,912 vehicles were tracked both east and westbound. The 85<sup>th</sup> percentile of speed driven was 31.48 mph with the overall average speed of 28.39 mph driven. The posted speed limit is 25 mph.

The Police Department's records indicate the following collision history:

2016 3 collisions

2017 0 collisions

2018 1 injury collision

On Tuesday, February 13, 2018, 25 mph signage was installed with street stamping.

# 9. Req. #2018-004: Jeffries Ave (at Plymouth Elementary School) - Speeding / Traffic / Safety

Resident requesting a speed study, speed cushions, and traffic calming on Jeffries, at Plymouth Elementary School, due to excessive speeding in a school zone. The Police Department conducted a data-trailer speed study on Tuesday, February 6 through Monday, February 12, 2018. The statistics indicate that 11,785 vehicles were tracked both east and westbound. The 85<sup>th</sup> percentile of speed driven was 35 mph with the overall average speed of 29 mph driven. The posted speed limit is 25 mph.

# 10. Req. #2018-015: 525 Terrado Rd – Speeding / Traffic / Safety

Resident requesting a speed study, speed cushions, and traffic calming due to excessive speeding. The Police Department conducted the following data-trailer speed studies:

Tuesday, February 27 through Sunday, March 4, 2018. The statistics indicate that 2,298 vehicles were tracked southbound. The 85<sup>th</sup> percentile of speed driven was 23.87 mph with the overall average speed of 19.21 mph driven.

Tuesday, March 6 through Monday, March 12, 2018. The statistics indicate that 3,522 vehicles were tracked northbound. The 85<sup>th</sup> percentile of speed driven was 25.63 mph with the overall average speed of 19.58 mph driven.

Wednesday, June 13 through Tuesday, June 19, 2018. The statistics indicate that 3,557 vehicles were tracked both north and southbound. The 85<sup>th</sup> percentile of speed driven was 30.58 mph with the overall average speed of 27.8 mph driven. The residential prima facie speed limit is 25 mph.

The Police Department's records do not indicate any collisions at the Terrado and Lemon intersection. *Cross-referenced with Reg. #2018-018.* 

# 11. Req. #2018-018: 1130 East Lemon Ave (Bradoaks Elementary) – Speeding / Traffic / Safety

Resident requesting a speed study, speed cushions, and traffic calming on Lemon, at Bradoaks Elementary School, due to excessive speeding in a school zone. The posted speed limit is 25 mph When Children are Present, from Mountain to Bradbury Rd. Bradbury Rd to the east of City limits is posted at 30 mph.

The Police Department conducted the following data-trailer speed studies:

Thursday, April 19 through Wednesday, April 25, 2018. The statistics indicate that 12,224 vehicles were tracked both east and westbound. The 85<sup>th</sup> percentile of speed driven was 34 mph with the overall average speed of 29.3 mph driven.

Tuesday, July 10 through Wednesday, July 18, 2018. The statistics indicate that 10,920 vehicles were tracked eastbound. The 85<sup>th</sup> percentile of speed driven was 37 mph with the overall average speed of 31.7mph.

The posted speed limit is 30 mph.

The Police Department's records indicate one collision at the Lemon Avenue and Bradbury Road intersection from 2016 to the present day. *Cross-referenced with Req.* #2018-015.

# 12. Req. #2018-019: 322 North Mayflower Ave - Speeding / Traffic

Resident requesting a speed study and traffic calming due to excessive speeding. The Police Department conducted the following data-trailer speed studies:

Wednesday, May 23 through Tuesday, May 29, 2018. The statistics indicate that 1,628 vehicles were tracked southbound. The 85<sup>th</sup> percentile of speed driven was 26.34 mph with the overall average speed of 22.29 mph driven.

Wednesday, May 30 through Tuesday, June 5, 2018. The statistics indicate that 6,618 vehicles were tracked northbound. The 85<sup>th</sup> percentile of speed driven was 22.28 mph with the overall average speed of 16.41 mph driven. The residential prima facie speed limit is 25 mph.

# 13. Req. #2018-020: 790 Oakglade Drive (No Parking Except by Permit Only (END) signage) – Parking

Resident requesting to have the No Parking Except by Permit Only (END) signage moved to the north of her property and around the curve of 800 Oakglade. This signage is to deter Canyon Park visitors from parking in the residential neighborhood.

# 14. Req. #2018-021: Olive Avenue (between Myrtle and Primrose) - Parking

Resident requesting the removal of the short areas of red curbing and the installation of the "T" marked parking stalls on the south side of Olive.

# 15. Req. #2018-022: Mayflower Ave and Huntington Dr Walgreens Signage / Myrtle Ave and 210 Fwy Signage / Foothill Blvd and Madison Ave Starbucks - Traffic / Safety

- 4. Resident requesting enforcement of the double yellow line restriction at the Starbucks at Foothill and Madison.
  - a. There is a slight break in the double yellow line on the south side at the Starbucks drive through exit.

Cross-referenced with Req. #2015-188, #2016-026, and Req. #2017-054.
