TITLE: Canyon Park and Hillside Wilderness Preserve Patrol Update for January 2019

OBJECTIVE: To provide an update on incidents, maintenance, and public comments related to Canyon Park and the Hillside Wilderness Preserve (HWP) recorded for the month of January 2019.

BACKGROUND: For over a century, Canyon Park has been used as a recreational park by visitors and Monrovia residents. Services in Canyon Park include special events, Naturalist led night hikes, interpretive tours, a Nature Center, trails, a waterfall, and views of the San Gabriel Valley. In addition, Park Naturalists, with the support of volunteers, maintain the trail system and facilities.

In 2016, the City opened over 4.5 miles of HWP trials providing passive recreational opportunities for the community. Park Naturalists patrol the HWP as well as urban parks two times a day by vehicle, utility terrain vehicle, and foot. Park Naturalists also respond to calls related to Monrovia's No Smoking in Parks Ordinance.

The included Canyon Park and HWP Logs provide additional information related to the Comments, Maintenance, Incidents, and Events that occurred in January 2019.

ANALYSIS: During the month of January 2019, Canyon Park and HWP were closed from Thursday, January 17 to Sunday, January 26 due to heavy rains. Park Naturalists and Volunteers cleared slides, removed debris and repaired trails before re-opening the trails to the public on January 27. Park Naturalists completed 114 hours of maintenance throughout HWP and 140 hours in Canyon Park. The maintenance included brush clearance, trail repair, clearing dirt and landslides from heavy rains, and diverting water to prevent erosion. Park Naturalists and Volunteers assisted Monrovia Fire and CERT with their Urban Search and Rescue quarterly training in incident scenarios on the hiking trails. Programs for Canyon Park include Park Naturalists Education Tours for Wildrose and Monroe Elementary Schools for grades 2nd through 5th. On Sunday, January 27, Park Naturalists hosted the Kids Craft in the Canyon program where participants made Winter Bird Feeders.

RECOMMENDATION: Staff recommends the Community Services Commission move to receive and file CC-2, Canyon Park and Hillside Wilderness Preserve Patrol Update for January 2019.
