- 1. <u>Req. #2018-024: Blue ADA Curb Application and Policy and Procedure Parking</u> To establish a blue ADA curb application and policy and procedure for a resident requesting to have a blue ADA curb installed at their residence and assessing the path of travel.

# 1. Req. #2015-188: Gold Line – Mayflower and Central Aves – Safety

## 2. Mayflower Ave and Huntington Dr

Preliminary plans were discussed at the December 17, 2015, meeting. Intersection is currently being evaluated by Gibson Transportation Consulting, Inc. for the readjustment of lane lines. Committee to review signal timing. DO NOT BLOCK INTERSECTION signage installed on November 16, 2017, for north and southbound traffic.

#### 2. <u>Req. #2016-026: North and South Mayflower Ave (from Huntington Dr) – Safety</u>

Resident requesting to refresh street striping on north and south Mayflower from Huntington and/or to add raised pavement markers. Intersection is currently being evaluated by Gibson Transportation Consulting, Inc. for the re-adjustment of lane lines. DO NOT BLOCK INTERSECTION signage installed on November 16, 2017, for north and southbound traffic. *Cross-referenced with Req. #2015-188 and Req. #2017-054.* 

#### 3. <u>Req. #2017-039: Mayflower and Olive Aves (Monroe Elementary) – Traffic / Safety</u>

2. Resident requesting blue ADA curb / parking at the Mayflower and Olive intersection, at Monroe Elementary.

Current blue ADA curb on the north-west corner of Alta Vista and Olive.

# 4. <u>Req. #2018-023: Highway Safety Improvement Plan – Traffic / Safety</u>

Signal installation at Foothill and California, Foothill and Sunset, and intersection modifications at Huntington and Fifth, with Caltrans grant funding.

# 5. Reg. #2018-032: 118 North Primrose Ave (blue ADA curb) – Parking

Resident requesting a blue ADA curb in front of their residence due to a neighbor shared driveway, detached shared duplex garage at the rear of the property, and being an under-parked property.

# 6. <u>Req. #2018-033: 500 block of Wild Rose Ave (south side at Wild Rose Elementary)</u> <u>– Parking</u>

Wild Rose Elementary School is requesting the removal of the NO PARKING restrictions (7 a.m. - 9 a.m. and 1:30 p.m. - 3:30 p.m. school days only) on the 500 block of Wild Rose, south side of the street. Street sweeping parking restrictions are 9 a.m. - 11:30 a.m. Thursdays (north side) and Fridays (south side).

- 7. <u>Req. #2018-035: Canyon Blvd and Lime Ave (crosswalk) Traffic / Safety</u> Resident requesting a crosswalk at the intersection of Canyon and Lime.
- 8. <u>Req. #2018-042: Sierra Terrace between Sesmas St and Royal Oaks Dr (speed cushions) Speeding</u>

Resident requesting a speed study and traffic calming on Sierra Terrace between Sesmas and Royal Oaks.

9. <u>Req. #2018-044: Fifth Ave between Duarte Rd and California St (speed cushions) –</u> <u>Speeding</u>

Resident requesting a speed study and traffic calming on Fifth between Duarte and California.

- 10. <u>Req. #2019-001: 100 block of North Madison Ave Speeding</u> Resident requesting a speed study and traffic calming on North Madison.
- 11. <u>Req. #2019-002: Plymouth Avenue Elementary School Crosswalk</u> California Highway Patrol Officer requesting a crosswalk, at the Rochelle and Boley intersection, at Plymouth Elementary School.
- Req. #2019-005: North Highland Pl at the Scenic Dr fork Speeding Resident requesting a speed study and traffic calming on N Highland and the Scenic fork.
- 13. <u>Req. #2019-007: 410 East Cherry Ave (blue ADA curb) Parking</u> Resident requesting a blue ADA curb in front of their residence.
- 14. <u>Req. #2019-008: Valley View (between Shamrock and Mountain Aves) Speeding</u> Resident requesting a speed study and traffic calming on Valley View between Shamrock and Mountain.
- 15. <u>Req. #2019-009: Ocean View (between Shamrock and Mountain Aves) Speeding</u> Resident requesting a speed study and traffic calming on Ocean View between Shamrock and Mountain.

- <u>Req. #2019-010: 129 North Primrose Ave Speeding</u> Resident requesting a speed study, traffic calming, and Deer Crossing signage on N Primrose between Foothill and Hillcrest.

Currently there is a NO RIGHT TURN ON RED for eastbound traffic on Lemon.
- <u>Req. #2019-016: West Colorado Blvd alleyway at Magnolia Traffic / Safety</u> Resident requesting a convex mirror to be installed on the SCE power pole for line-ofsite safety when exiting the alleyway at Magnolia.
- 8. <u>Req. #2019-017: 265 North Canyon Blvd (at Greystone) Speeding / Traffic /</u> <u>Safety</u>

Resident requesting a speed study and traffic calming on N Canyon at Greystone.

9. <u>Req. #2019-018: 1720 South Fifth Avenue (red curbing) – Parking / Traffic / Safety</u> Resident requesting red curbing at the mailboxes for access and for line-of-site safety.
