**MATTERS ON THE AGENDA:** If you wish to address the Planning Commission on a matter on the agenda, please wait until the Chair opens the public hearing or calls for public comment on that matter. For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

**AGENDA ITEMS:** The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

### **PUBLIC HEARINGS**

**PH-1 Conditional Use Permit CUP2016-02 (Service and Sales of Wine and Beer), Conditional Use Permit CUP2016-03 (Live Entertainment), Romero Estate Vineyard LLC DBA REV Winery/REV Brewing Co., applicant**

**Request:** Occupy two existing storefronts with a new winery/brewery with incidental retail sales of wine and beer for off-site consumption and incidental tasting of wine and beer, and allow live entertainment in an industrial building located in the PD (Planned Development Area) – 12 zone. Determine that the project is Categorically Exempt (Class 3) pursuant to the California Environmental Quality Act (CEQA).

**Recommendation:** Approve CUP2016-02 and CUP2016-03 pursuant to the recommendations in the Staff Report.

**PH-2 Ordinance No. 2016-02; PC Resolution No. 2016-02, Sierra Auto Properties, LLC, applicant**

**Request:** Amendment to the Monrovia Municipal Code, Title 17 (Zoning), to allow “Automobile Sales” in the M (Manufacturing) zone upon approval of a Minor Conditional Use Permit. Determine that the project is Exempt pursuant to Section 15061(b)(3) of the California Environmental Quality Act (CEQA).

**Recommendation:** Adopt Planning Commission Resolution PCR2016-02 recommending approval to the City Council of Ordinance No. 2016-02 as presented in the Staff Report.

**PH-3 Ordinance No. 2016-01; Planning Commission Resolution No. 2016-01, City of Monrovia, applicant**

**Request:** Amendment to the Monrovia Municipal Code, Title 17 (Zoning), Chapter 17.20 (Landscaping/Tree Preservation) to adopt the revised State Model Water Efficient Landscape Ordinance by reference, in accordance with State law. Determine that the project is Exempt pursuant to Section 15061(b)(3) of the California Environmental Quality Act (CEQA)

**Recommendation:** Adopt Planning Commission Resolution PCR2016-01 recommending approval to the City Council of Ordinance No. 2016-01 as presented in the Staff Report.
