TITLE: Canyon Park and Hillside Wilderness Preserve Patrol Update for July 2019

OBJECTIVE: To provide an update on incidents, maintenance, and public comments related to Canyon Park and the Hillside Wilderness Preserve (HWP) recorded for the month of July 2019.

BACKGROUND: For over a century, Canyon Park has been used as a recreational park by visitors and Monrovia residents. Services in Canyon Park include special events, staff led hikes, interpretive tours, a Nature Center, access to trails, a waterfall, and views of the San Gabriel Valley. In addition, the staff and volunteers maintain the trail system and facilities.

In 2016, the City opened over 4.5 miles of HWP trails providing passive recreational opportunities for the community. Park Naturalists patrol the HWP as well as urban parks two times a day by vehicle, utility terrain vehicle, and foot. Park Naturalists also respond to calls related to Monrovia's Smoking Ban Ordinance in parks.

The included Patrol Log provides additional information related to the Comments, Maintenance, Incidents, and Events for July 2019.

ANALYSIS: During the month of July 2019, Staff and Volunteers worked on maintaining Canyon Park and HWP hiking trails. Staff and Volunteers completed 102 hours of maintenance throughout HWP and 123 hours in Canyon Park. The maintenance included brush clearance, erosion control, and invasive species removal.

Each year, as a precaution, Canyon Park and the HWP are closed to the public from July 3 – July 5. The closure is in response to limited resources related to Fire Protection during the holiday weekend as well as heighten risk of unsafe use of fireworks. On July 4, Park Naturalist assisted with the City's 4th of July Event in Library Park.

On Monday, July 29, Canyon Park's Waterfall Trail was temporarily closed due to a large branch that fell onto the trail making it unsafe for hikers to pass. On Wednesday, July 31 West Coast Arborist removed the large branch and the trail was reopened to public.

Park Naturalist and Volunteers hosted two Family Hike and Campout Events on Saturday July 13 – Sunday, July 14 and Saturday, July 27 – Sunday, July 28. Participants enjoyed day and night hikes, family craft activities, library Storytime, s'mores, and camping related activities.

In July, Park Naturalists, in partnership with the Junior Research Academy, led group hikes on Tuesday July 2, 16 and 30.

At the July 9, 2019 Community Services Commission meeting, the Commission presented staff with some questions related to the June 2019 Patrol Log. Specifically, the Commission questioned the drop in the number of Patrols as well as the number of Pedestrians Counted in 2019 as compared to 2018. Again, this month, the number of Patrols as well as the number of Pedestrians Counted is less as compared to 2018. Staff has reviewed the item carefully and can attribute the differential to a few factors.

- 1. In 2018, Park Naturalist patrolled the Hillside Wilderness Preserve in a vehicle. Doing so allowed the staff to cover a larger territory as well as do more patrols in one shift. This approach did allow for more coverage; however, staff began to notice hazards were being overlooked and needed maintenance items were being missed. Understanding how many users we have in HWP is important; however, ensuring the trails are safe is critical. In response to this finding, staff are now parking the vehicle and conducting foot patrols more frequently. This takes much longer and as a result, we are seeing fewer Patrols on the monthly Log. Less frequent Patrols yields a lower Pedestrian Count.
- 2. In 2018, Canyon Park was fortunate to have a few dedicated volunteers able and willing to work the Entry Station at Canyon Park. One of the key responsibilities for this positon is to collect payment from visitors for parking in Canyon Park. The practice had been in place for many years and of course the team has ultimate trust in the volunteers; however, having volunteers handle cash transactions without the assistance of staff is not best practice. As a result, a staff member is now needed in this role and therefore we have one less staff this year able to conduct patrols as compared to prior years. This again results in fewer Patrols and lower Pedestrian Counts.
- 3. Staff has reviewed the time in which the patrols are being conducted. Currently, staff are patrolling HWP twice a day, once in the late morning and once in the early afternoon. Staff recognizes that conducting the patrols during the times when the trails are more active may be preferred. Patrolling the trails in the early morning or late afternoon, when it is cooler, may allow for more interaction with the trail users. Staff will be looking into adjusting the schedule to allow for more frequent patrols during more active times of the day.

Staff is also looking into trail counters that may be deployed at the access points to capture more accurate counts. Doing so would allow us to have information that is consistent over time and not require additional staff resources. Staff will continue to research our options and report back to the Commission as needed.

RECOMMENDATION: Staff recommends the Community Services Commission move to receive and file CC-2, Canyon Park and Hillside Wilderness Preserve Patrol Update for July 2019.
