## **REPORTS FROM STAFF:**

## 1. Tina Cherry, Community Services Director

- a. Proposed Date for 2019 Holiday Tree Lighting Presented staff recommendation to host the Holiday Tree Lighting and Parade as two separate events; Holiday Tree Lighting on Tuesday, November 26, 5-8 p.m. and Parade on Thursday, December 5 and asked the Board for feedback.
- b. Budget Update Ms. Cherry provided a year-end Budget Update for FY18/19 and presented the FY19/20 approved budget including programs and events. Also provided an overview of revenues and expenditures. As of July 1, 2019, the fund balance is \$85,000.
- c. Follow Up on Board Member Comments
  - a. Vintage Stores in Old Town Vintage sales are allowed in Old Town; Community Development developed a Vintage Merchant Affidavit which articulates the required conditions. The business modified the business permit and signed the affidavit.

### 2. Katie Distelrath, Recreation Manager

a. Fall Programming Subcommittee Update - Ms. Distelrath provided a recap on the Fall Festival 2018 and provided staff recommendation to host this year's event on Saturday,

October 12, 12noon-4pm; planned activities include carriage rides, pet adoptions, pet booths, and dog parade. Also discussed the recommended event additions to include photo booths, face painting, scavenger hunt in Old Town, partner with MAFA to include art, Instagram contest, and partner with Pacific Productions to host an Oktoberfest at Library Park. Ms. Distelrath asked the Board for feedback.

Holiday Decorating Subcommittee Update – Ms. Distelrath provided a recap on the Holiday Decorating 2018 and discussed the event upgrades for the 2019 Holiday Decorating to include new bows, candy cane bows, and lighted gift boxes for Christmas trees. A three year contract with The Christmas Light Guy was approved by City Council.
