For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

AGENDA ITEMS: The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

PH-1 **Variance V2016-02**
207 South Magnolia Avenue – Applicant, Edwin K. Miedema II

Request: Allow a trash enclosure that was previously constructed without the required approvals to encroach into the minimum front yard and side yard setbacks. This property is located in the RM2500 (Residential Medium Density) zone.

Recommendation: Deny Variance V2016-02 pursuant to the recommendations in the Staff Report.

PH-2 **Conditional Use Permit CUP2000-03 (Amendment)**
622 – 626 South Myrtle Avenue – Applicant, Tony Banuelos

Request: Amendment to Conditional Use Permit CUP2000-03 allowing the indoor and outdoor service of beer and wine at an existing restaurant (Jakes Roadhouse) to accommodate an expansion of the restaurant in the Historic Commercial Downtown (HCD) zone. Determine that this project is Categorically Exempt (Class 1) from the California Environmental Quality Act (CEQA).

135 West Foothill Boulevard – Applicant, Sylvia Domotor, DVM

Request: Allow 24-hour emergency operations at an existing veterinary hospital. The subject property is located in the Neighborhood Commercial (NC) zone. Determine that this project is Categorically Exempt (Class 1) from the California Environmental Quality Act (CEQA).
