For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

**AGENDA ITEMS:** The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

**PH-1** **Conditional Use Permit CUP2016-14**  
**415 South Myrtle Avenue, Units B & C – Applicant, Judy Wong & Cindy Lee**

**Request:** Allow the operation of a café and indoor children's play area, "Oh Mulberry Bush", within a two-story 1,600 square foot commercial tenant space in the Historic Commercial Downtown (HCD) Zone. Determine that this project is Categorically Exempt (Class 1) from the California Environmental Quality Act (CEQA).
