**MATTERS ON THE AGENDA:** If you wish to address the Planning Commission on a matter on the agenda, please wait until the Chair opens the public hearing or calls for public comment on that matter. For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

**AGENDA ITEMS:** The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

### **PUBLIC HEARINGS**

**PH-1 Conditional Use Permit CUP2015-17; 123-137 West Pomona Avenue, Paul Kalemkiarian, applicant**

**Request:** Occupy an existing industrial building with an office use, warehousing, and a new retail establishment with incidental wine tasting. Allow the sale of wine and beer for off-site consumption to be located in an existing industrial building in the PD (Planned Development Area) - 12 zone. Determine that the project is Categorically Exempt (Class 1) pursuant to the California Environmental Quality Act (CEQA).

**Recommendation:** Approve CUP2015-17 pursuant to the recommendations in the Staff Report.

**PH-2 Ordinance No. 2016-01; PC Resolution No. 2015-16.**

**Request:** Amend Chapter 5.96 of Title 5 and Chapter 17.44 of Title 17 of the Monrovia Municipal Code, the City's prohibition on medical marijuana dispensaries and related activities, to be consistent with the "Medical Marijuana Regulation and Safety Act," recently adopted by the California Legislature. The proposed ordinance will add cultivation, distribution, and transportation of medical marijuana to the list of marijuana-related activities that are prohibited in the City. Determine that the project is Categorically Exempt (Class 1) pursuant to the California Environmental Quality Act (CEQA).
