# 2. Req. #2019-032: 534 Parker Ave (speed cushions) - Speeding / Traffic / Safety

Gibson Transportation Consulting, Inc. conducted a 24-hour speed study on Thursday, September 26, 2019. The statistics indicate that 419 vehicles were tracked both east and westbound. The 85<sup>th</sup> percentile of critical speed driven was 32 mph with an overall average of 25 mph. The residential prima facie speed limit is 25 mph.
