

Minutes of the Regular Meeting of the Monrovia Planning Commission August 14, 2019, 7:30 P.M.

CONVENE: Chair Schaeffler convened the Regular Meeting of the Monrovia Planning Commission on Wednesday, August 14, 2019, at 7:30 p.m. in the City Council Chambers, 415 South Ivy Avenue, Monrovia, California. In attendance were Community Development Director Craig Jimenez, Planning Division Manager Sheri Bermejo, Assistant City Attorney Carol Lynch, Assistant Planner Austin Arnold, and Planning Technician Vincent Gillespie.
