**MATTERS ON THE AGENDA:** If you wish to address the Planning Commission on a matter on the agenda, please wait until the Chair opens the public hearing or calls for public comment on that matter. For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

**AGENDA ITEMS:** The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

**PUBLIC HEARINGS**

**PH-1 Conditional Use Permit CUP2015-07/CUP2015-11; 417 South Myrtle Avenue, Jamm Foods Inc., applicant**

**Request:** Allow the indoor and outdoor service of beer and wine at a new restaurant (Merengue Cafe) to be located in an existing commercial building in the HCD (Historic Commercial Downtown) Zone. Determine that the project is Categorically Exempt (Class 1) pursuant to the California Environmental Quality Act (CEQA).

**Recommendation:** Adopt the Resolution approving CUP2015-07/CUP2015-11, as presented in the Staff Report.

**PH-2 Conditional Use Permit CUP2015-08/CUP2015-09; 860 West Foothill Boulevard, Blake Megdal (c/o Elliot Megdal & Associates), applicant**

**Request:** Construct a 950 square foot drive thru coffee shop (Starbucks), operating during late-night hours (4:00 AM to 6:00 AM). The existing building will be demolished. This property is located in the NC (Neighborhood Commercial) zone. Determine that the project is Categorically Exempt (Class 3) pursuant to the California Environmental Quality Act (CEQA).

**Recommendation:** Adopt the Resolution approving CUP2015-08/CUP2015-09, as presented in the Staff Report.

**PH-3 Conditional Use Permit CUP2015-10; 1311 South Shamrock Avenue, Tania Torres (Monrovia Preschool and Day Care Center), applicant**

**Request:** Allow a Preschool and Day Care Center to operate in an existing 6,000 square foot industrial building in a Manufacturing Zone. Determine that the project is Categorically Exempt (Class 1) pursuant to the California Environmental Quality Act (CEQA).

**Recommendation:** Adopt the Resolution approving CUP2015-10, as presented in the Staff Report.
