MATTERS ON THE AGENDA: If you wish to address the Planning Commission on a matter on the agenda, please wait until the Chair opens the public hearing or calls for public comment on that matter. For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

AGENDA ITEMS: The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

PUBLIC HEARINGS

PH-1 Conditional Use Permit CUP2015-08/CUP2015-09; 860 West Foothill Boulevard, Blake Megdal (c/o Elliot Megdal & Associates), applicant, continued

Request: Construct a 950 square foot drive thru coffee shop (Starbucks), operating during late-night hours (4:00 AM to 6:00 AM). The existing building will be demolished. This property is located in the NC (Neighborhood Commercial) zone. Determine that the project is Categorically Exempt (Class 3) pursuant to the California Environmental Quality Act (CEQA).

Recommendation: Adopt the Resolution approving CUP2015-08/CUP2015-09, as presented in the Staff Report.

PH-2 Variance V2015-09; 545 Cloverleaf Way, Chris Kidd, applicant

Request: Approve a variance to construct a 1,008 square foot 2 level accessory structure (2 car garage at driveway elevation and storage area below) that encroaches into the side yard setback. A 1'-6" side yard setback is proposed (in lieu of 15' required by code) adjacent to the north property line. This property is located in the RF (Residential Foothill) zone. Determine that the project is Categorically Exempt (Class 3) pursuant to the California Environmental Quality Act (CEQA).

Recommendation: Adopt the Resolution approving V2015-09, as presented in the Staff Report.
