MATTERS ON THE AGENDA: If you wish to address the Planning Commission on a matter on the agenda, please wait until the Chair opens the public hearing or calls for public comment on that matter. For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

AGENDA ITEMS: The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

PH-1 Tentative Tract Map No. 72951/Conditional Use Permit CUP2014-17/Variance V2014-02, 721 West Duarte Road, Twen Ma, applicant, continued

Request: Construct a two-story, 7-unit, condominium development with subterranean parking. A variance is requested to allow a reduction in private recreation space. This property is located in the RH (Residential High Density) Zone. Determine that the project is Categorically Exempt (Class 3) pursuant to the California Environmental Quality Act (CEQA)

Recommendation: Approve Tentative Tract Map No. 72951, Conditional Use Permit CUP2014-17 and Variance V2014-02

PH-2 General Plan Amendment GPA2014-03/Planning Commission Resolution PCR2014-10, Zone Change ZC2014-02/Ordinance No. 2014-12/Planning Commission Resolution No. 2014-11; 311 West Foothill Boulevard, Jiaming USA, Inc/Aztec Hotel, applicant.

PH-3 Variance V2014-03; 117 North Heliotrope Avenue, Norma Nunez, applicant

Request: Allow an already constructed front porch to encroach 5' into the required front yard setback (15' in lieu of 20'). This property is located in the RM3000 (Residential Medium Density) Zone. Determine that the project is Categorically Exempt (Class 1) pursuant to the California Environmental Quality Act (CEQA)

Recommendation: Deny Variance V2014-03
