PH-1 General Plan Amendment GPA2014-02/Planning Commission Resolution No. PCR2014-03; Repeal Station Square Specific Plan/Planning Commission Resolution No. 2014-05; Zoning Ordinance Text Amendment and Zone Change ZC2014-01/Planning Commission Resolution No. PCR2014-04/Ordinance No. 2014-03, Planned Development-Area 12 Station Square Transit Village covers the area bounded by Evergreen Avenue, Magnolia Avenue, Duarte Road, and Shamrock Avenue, City of Monrovia, applicant

Request: Amend the text to the Land Use Element of the General Plan modifying the "Station Square Transit Village" section and the guidelines for PD-12 Station Square Transit Village regarding land use, goals and policies, including reduction of the minimum development size from three (3) acres to two (2) acres; repeal the Station Square Specific Plan, which covers approximately 25 acres in the Station Square Transit Village area; amend the Zoning Ordinance to remove the Station Square Specific Plan from Section 17.04.035 of the Monrovia Municipal Code; and a Zone Change to the official zoning map changing part of the SP (Specific Plan) designation within Station Square Transit Village area to PD-12 (Planned Development-Area 12) (collectively, the "proposed project"). Environmental Impact Report certified in 2008 (SCH #2007021135)

Recommendation: Adopt Planning Commission Resolution Nos. PCR2014-03, PCR2014-05 and PCR2014-04

PH-2 Tentative Parcel Map No. 72777; Conditional Use Permit CUP2014-08; The Parks at Station Square Specific Plan; Planning Commission Resolution 2014-06; Zoning Ordinance Text Amendment; Planning Commission Resolution 2014-07/Ordinance No. 2014-04; Mitigated Negative Declaration; Planning Commission Resolution 2014-08, Southeast corner of Pomona and Magnolia Avenues (vacant property previously addressed 1622 South Magnolia Avenue and 204 West Pomona Avenue), The Parks at Monrovia Station Square 1, LLC Samuelson and Fetter, applicant

Request: Develop a 2.819 acre site with a 5 story, 261-unit apartment complex and a 7 level parking structure with 418 parking spaces pursuant to a specific plan. "The Parks at Station Square Specific Plan" will provide a land use plan, development regulations, and design guidelines to facilitate the development. The project site consists of several vacant parcels that will be consolidated into one parcel to accommodate the development.

The proposed development requires approval of the following: a tentative parcel map consolidating several parcels into one parcel; "The Parks at Station Square Specific Plan;" an amendment to the Zoning Ordinance to add "The Parks at Station Square Specific Plan" to Section 17.04.035 of the Monrovia Municipal Code; and a conditional use permit to construct the development. Determine that

the project is Categorically Exempt (Mitigated Negative Declaration) pursuant to the California Environmental Quality Act (CEQA)

Recommendation: Adopt Planning Commission Resolutions Nos. PCR2014-08, PCR2014-06, PCR2014-07 and adopt the following resolution recommending the repeal of Tentative Tract Map No. 70357 and approval of Tentative Parcel Map No. 72777 and Conditional Use Permit CUP2014-08
