MINUTES OF THE REGULAR MEETING OF THE MONROVIA CITY COUNCIL HELD TUESDAY, FEBRUARY 4, 2020, 7:30 P.M.

CONVENE: Mayor Tom Adams convened the Regular Meeting of the Monrovia City Council on Tuesday, February 4, 2020, at 7:31 p.m. in City Council Chambers, 415 South Ivy Avenue, Monrovia, California. In attendance were City Manager Dylan Feik, City Attorney Craig Steele, and City Clerk Alice D. Atkins.

Community Development Director Jimenez responded to questions about tribal artifact mitigation measures and provision for open space with new developments of 200 units or more.

It was moved by Mayor Pro Tem Spicer, seconded by Councilmember Shevlin, to adopt Resolution No. 2020-08, with modified language in the mitigation measures MM CUL-1 through MM CUL-5, replacing the term "archeological resources" with "Tribal Cultural Resources and archaeological resources. The motion carried with a unanimous roll call vote.

It was moved by Mayor Pro Tem Spicer, seconded by Councilmember Shevlin, to adopt Resolution Nos. 2020-09, 2020-10, 2020-11, and introduce, waive further reading, and read by title only Ordinance No. 2019-13. The motion carried with a unanimous roll-call vote.

City Attorney Steele read the title of Ordinance No. 2019-13 as follows:
