E-Waste Disposal Program

- In early 2020, staff coordinated with Athens Services to establish an E-Waste drop off location at the Public Works Yard
- For the initial roll out, the location has been two dumpsters in front of Public Works to accept all types of E-Waste
- Athens is removing approximately 4 full dumpsters (12 Yards) of E-Waste on a weekly basis.
