TITLE: Canyon Park and Hillside Wilderness Preserve Patrol Update for June 2020

OBJECTIVE: To provide an update on incidents, maintenance, and public comments related to Canyon Park and the Hillside Wilderness Preserve (HWP) recorded for the month of June 2020

BACKGROUND: For over a century, Canyon Park has been used as a recreational park by visitors and Monrovia residents. Services in Canyon Park include special events, Naturalist led night hikes, interpretive tours, a Nature Center, trails, a waterfall, and views of the San Gabriel Valley. In addition, Naturalists and volunteers maintain the trail systems and facilities.

In 2016, the City opened over 4.5 miles of HWP trials providing passive recreational opportunities for the community. Park Naturalists patrol the HWP and urban parks two times a day by vehicle, utility terrain vehicle and foot. Park Naturalists also respond to calls related to Monrovia's Smoking Ban Ordinance.

On Friday, March 13, 2020, in response to the potential exposure of COVID-19 and under the guidance received by local, state and federal officials, the decision was made to close the Community Center, Library, HWP and Canyon Park to the public.

On Tuesday, May 26, 2020 Canyon Park reopened to the public through a reservation only online system. The new reservation system helps ensure a limited number of visitors, both residents and nonresidents, have the opportunity to enjoy Canyon Park while also managing large crowds. Reservations are limited to 70 per timeslot, with three timeslots available every weekday. All visitors looking to enter the park must have a reservation, whether driving, biking or walking into Canyon Park. A \$5.00 parking fee is required for visitors to park inside Canyon Park. Trail modifications were established to ensure safe, physical distancing such as:

- One-Way Trail Loops
- Portions of the Waterfall Trail and Ben Overturf Trail closed
- Limited Trail Use Hours
 - o Monday Friday: 6:30 a.m. to 6:00 p.m.
 - Closed Saturdays, Sundays and Holidays

ANALYSIS: During the month of June 2020, Park Naturalist worked on maintaining Canyon Park and HWP hiking trails. Park Naturalists still completed 18 hours of maintenance throughout HWP and 129 hours in Canyon Park. The maintenance included brush clearace and erosion control. The report provided summariez maintenance and usage activity in HWP and Canyon Park.

Hillside Wilderness Preserve

Staff has observed the usage of HWP trails has stabilized back to the average number of usage prior to the COVID-19 closures. Staff believes this is due to other local recreation areas re-opening to the public. During the month of June, Staff observed consistant number of users hikers and mountain bikers in HWP.

On April 21, 2020, City Council awarded Belfree Contractors a contract to repair two locations of HWP where heavy erosion has damaged the trails from this last rain season. Due to Belfree's schedule, they are unable to perform the repairs until August 2020.

Canyon Park

The provided report details trail reservation system during the month of June. Staff continues to recieve positive feedback from Canyon Park visitors realted to the reservation system and modified trail loop. Visitors continue to comment on feeling safe and comfortable while hiking our trails.
