Good evening, City Council and Planning Commission,

On behalf of our group, Monrovia Housing & Tenants Advocates, we want to thank you for tonight's meeting

that includes the Housing Element update. The Monrovia Housing & Tenants Advocates, is a grassroots group of concerned citizens who bring a collective voice for affordable for-purchase and rental housing in Monrovia by ensuring adequate public and private resources, efficient and effective housing programs, and strong support among public officials at all levels of government.

As we all know the Housing Element is an important and valuable document. The current Housing Element, after 8 years, expires at the end of 2021. The new document will represent housing requirements and goals for the following next 8 years beginning in 2022.

Sections in this document that need to be strengthen or added, include:

- 1. The addition of an Inclusionary Housing ordinance whereby, developers that want to build or convert units in our city, must set aside, 25% for extremely low to moderate income levels, as dictated by the Regional Housing Needs Assessment, RHNA.
  - a. If a developer does not wish to set aside 25% of their project, they must build something offsite in another location in our city, to make up for what they would have built within their project. This must be built concurrently with the main project, or even before the main project.
  - b. If a developer does not wish to build onsite or offsite as described above, they may pay an inlieu fee\* [we will get back to you on this]. This in-lieu fee will go into a special housing fund held by the city, to be used exclusively on other housing building projects.
- 2. The increase of production and completion of affordable senior housing units that focus particularly on the extremely low, very-low and low-income levels. [In the current Housing Element, that low-level income would be \$47,850 for a one person household, for example.]
- 3. The increase of production and completion of affordable housing for the first time buyers, along with listings of potential grants available to them.
- 4. The increase and completion of affordable Accessory Dwelling Units, ADUs.
  - a. Certain design models would be pre-approved, saving time and money. With those preapproved models, plans could be streamlined through plan check, and also some fees would be removed, thus making ADUs attractive to homeowners to incentivize them to build.

We look forward to participating with you to improving and strengthening the Housing Element that will improve the housing needs for the city of Monrovia.
