 Req. # 2018-044 – Fifth Avenue from Duarte Road and California Street: Resident requests to install speed cushions. Recommendation: Staff recommends installation of speed legends, a centerline stripe, and additional signage.

- Req. #2019-024 East Cypress Avenue from California Avenue to Shamrock Avenue: Resident requests to install speed cushions. Recommendation: Staff recommends installation of a centerline stripe.
- Req. #2020-001 Olive Avenue and Mayflower Avenue: Resident requests to increase pedestrian safety at intersection of Olive Avenue and Mayflower Avenue. Recommendation: Staff recommends removal of the intersections' southern crosswalk and installation of "Keep Clear" pavement markings to facilitate turns from Olive Avenue onto Mayflower Avenue.

- Req. #2020-006 Bradbury Road from Lemon Avenue to Orange Avenue: Resident request for traffic calming on Bradbury Road, south of Lemon Avenue. Recommendation: Receive update on installation of speed legends, a centerline stripe, and a high visibility crosswalk at the intersection of Bradbury Road and Lemon Avenue to resolve this request.
- Req. #2020-007 Hacienda Drive from Lemon Avenue to Orange Avenue: Resident requests installation of speed humps. Recommendation: Receive an update on the installation of speed limit signs and speed legends at mid-block to resolve this request.
