My objections to this are as follows: According to the Secretary of State, the lobbying status of Tony Rice is "revoked". The lobbying status of Rice/Englander and Associates is "suspended". The last time either of them was legitimately registered was during the 2013 to 14 legislative session. Search for an LLC by the name Rice/Englander and Associates turns up "no results". I assert that Tony Rice is an unlicensed lobbyist fronting a defunct company. Furthermore, while under contract to the city during the past 3 years, he was required to furnish proof of insurance. The contract states QUOTE "Consultant shall maintain current endorsements on file with the City Risk Manager. Consultant shall provide proof to the City Risk Manager that policies expiring during the term of the agreement have been renewed. Consultant shall furnish such proof at least 2 weeks prior to expiration." END QUOTE. I asked the city manager to provide copies of the policies. So today he contacted the insurance company and forwarded to me 3 years of insurance policies, the most recent of which expired September 29, 2020. The city manager stated QUOTE "Mr. Rice did renew his insurance for this coming year and the city is waiting for the renewal document from his insurer". He was required to submit that renewal document two weeks before September 29th. He didn't. He breached the contract. When the City Manager contacted the insurance company today to request those expired documents I don't understand why he didn't request the current one that the city is waiting for. It is now 3 weeks overdue and counting. Because of all these irregularities Tony Rice and Rice/Englander and Associates do not deserve any more of Monrovia's largess. I won't bother to critique the ill-timed, tone-deaf, pathetic prison spending scam he advocates for. By the way, can anyone tell me who Mr.or Mrs. Englander and the Associates are?

Monrovia has the dubious distinction of being the only city in California to subsidize the Lyft Company of Delaware. Lyft and four of its accomplices in the transportation business have ponied up an astounding 184 million dollars to publicize their initiative, Proposition 22. I have already received two mailers and been besieged by ubiquitous television and radio commercials. Prop 22 advertising presents taxi and food delivery drivers who claim to be satisfied with the conditions of their employment and whose jobs will supposedly be lost if the measure is not enacted. Their motto is "save our jobs". Maybe they don't realize that Lyft is actively developing self-driving cars in order to eliminate their jobs. I have not heard any mention about saving bloated corporate profits. Problems like crime and homelessness are in part due to the egregious wealth and income inequality that exists in our society. The rich white collar criminal tax and regulation evaders who don't pay their fair share and who disregard labor laws must be held responsible for contributing to those social problems.

One initiative is not on the ballot. Last year the Council hurriedly held a special election to enact a three quarter cent city sales tax. I presented undisputed proof that no threat existed based on my communication with those two agencies, but I guess the truth doesn't matter to politicians who are determined to tax and spend. There is no County sales tax on the ballot. WE GOT PLAYED!
