At the last Council meeting it was revealed that Monrovia's man in Sacramento, Tony Rice, is an unregistered revoked lobbyist who has not been reporting his activity to the Secretary of State like he's supposed to. Thank you Members of City Council, City Manager Dylan Feik, City Attorney Craig Steele for following-up on a possible gubernatorial pardon for Steven Kiyoshi Kuromiya (City Council Directive of 5 August 2020).

It may be both a blessing and a curse that Los Angeles' juvenile criminal records before 1970 have now been wiped out. Kuromiya's arrest at 13 years of age in Monrovia on 14 August 1956 for Calif Penal Code 836.3, 288(a) and his subsequent time in detention were indelibly imprinted on his experience as a Monrovian, and that of his family.

The criminalization of homosexual activities is an unfortunate part of our shared history that simply cannot be wiped away by the deletion of records. For this reason, I encourage our City to find some way to celebrate Kiyoshi Kuromiya's life as a civil rights activist and as a gay rights activist. We should find a way to now claim him as one of our own in Monrovia.

I certainly will be very willing to collaborate in any way.
