**Recommendation:** Staff recommends the Committee review the work completed and dismiss the request.

- Req. #2019-023 North Canyon Boulevard from Scenic Drive to Ridgeside Drive: Resident is requesting street speed signage and street stamping. Recommendation: Staff recommends the Committee approve targeted traffic enforcement along the block, and direct staff to prepare additional traffic calming options for consideration at a future Traffic Safety Committee Meeting.
- Req. #2019-025 East Greystone Avenue between Myrtle Avenue and Canyon Boulevard: Resident is requesting speed cushions or a 4-way stop at the intersection of Greystone Avenue and Ivy Avenue. Recommendation: Staff recommends the Committee approve targeted traffic enforcement

along the block, and direct staff to prepare additional traffic calming options for consideration at a future Traffic Safety Committee Meeting.
