REPORTS ON PREVIOUS AGENDA ITEMS

1. **Req. #2020-013 860 West Foothill Boulevard: Advisory Review of a proposed site plan to add an additional drive-thru queue lane and update previously approved Traffic Mitigation Plan.** Staff recommends approval of the additional drive-thru queue lane at 860 West Foothill Blvd.

2. **Req. #2020-010- 1301 South Shamrock Avenue: Business owner is requesting to install a yellow curb, remove the red curb from the east side of the 1200-1300 blocks of South Shamrock Avenue, and to install a 4-way stop at the intersection of Los Angeles Avenue and Sherman Avenue.** Staff recommends:
 - a. Approval of installation of a yellow curb and a green temporary parking zone along the 600 block of Los Angeles Avenue, adjacent to the property.
 - b. Removal of portions of red curb from the east side of the 1200-1300 block of South Shamrock Avenue.
