

**MINUTES OF THE
MONROVIA COMMUNITY SERVICES COMMISSION
Tuesday, March 9, 2021**

**Pursuant to the Governor's Executive Order N-29-20,
Commissioners and Staff participated via teleconference.**

In accordance with Executive Order N-29-20 and guidance from the California Department of Public Health on gatherings, members of the public were encouraged to participate in the meeting remotely. Public comment was accepted by email to Community Services Director Tina Cherry prior to 5:00 p.m. on the day of the meeting.

CONVENE: Chair Villegas convened the Regular Meeting of the Community Services Commission on Tuesday, March 9, 2021 at 7:04 p.m., via teleconference, Monrovia, California. SCR-1 Update on the Lucinda Garcia Park Improvement Project - Community Services Director Tina Cherry provided an update. The RFP was issued on February 26 and to date we have received nine bids. The RFP deadline is Thursday, March 25. The Sub-Committee will review proposals the week of March 29.

- a. Provided an overview of the Spring programs that included Youth Sports Fitness Camp, Hippy Hoppity Spring Photo-Op, Spring Fitness Challenge Family Adventure from Home, Spring Stop & Hop Drive thru EGG-stravaganza, Earth Day, Arbor Day 2021, and a 10K Virtual Family Fun Walk/Run during the week of May 3.

Tina Cherry, Community Services Director

- a. Provided an update on Canyon Park Restoration. The U.S. Forest will remain closed through April 2022. Three focus areas for the reopen include trail restoration, removal of hazardous trees, and trail signage. Staff is working on weed abatement, Kiosk repairs, painting railings, installation of drinking fountains and Nature Center exhibits.
- b. Provided a brief overview of the Ad Hoc Committee on Equity and Inclusion presentation. The presentation video will be available online on February 11. The next step is the Committee will submit the report to Council.
- c. Provided an overview of the Study Session and the 2021 Goals for the Commission and staff.

- a. Chair Villegas – The Mental Health Consortium meeting included a discussion on mental health issues and assistance for parents during the pandemic, and a presentation on stressors.
