#### PUBLIC HEARINGS

#### PH-1 <u>Conditional Use Permit CUP2019-0003 (Amendment)</u> 320 West Chestnut Avenue; Paul Kalemkiarian for Wine of the Month Club; Applicant

**Request:** Approve an amendment to Conditional Use Permit (CUP2019-0003) to increase the floor area of the wine tasting room from 378 square feet to approximately 990 square feet, and to allow online sales and incidental retail sales of distilled spirits (ABC License Type 21) in conjunction with an existing wine warehousing and mail order business (Wine of the Month Club). The existing Conditional Use Permit allows the off-site sale of wine (Type 20) and incidental wine tasting (Type 2). The subject property is located in the M (Manufacturing) zone. Determine that the project is Categorically Exempt (Class 1) from the California Environmental Quality Act (CEQA).

Recommendation: Approve Conditional Use Permit CUP2019-0003 (Amendment)

PH-2 Mitigated Negative Declaration (Planning Commission Resolution PCR2021-0002); Zoning Code Text Amendment ZA2021-0001 (Planning Commission Resolution PCR2021-0003); Tentative Parcel Map TPM 83202; Conditional Use Permits CUP2021-0006 through CUP2021-0011; and General Plan Conformity GPC2021-0002 for the properties located at 820 West Huntington Drive (Assessor's Parcel Numbers [APN] 8507-008-035, -041, -042, -044, and -070 through -072); Brook Reimer for Chick-Fil-A Inc, Applicant

**Request:** An application to develop a 2.09-acre site with a 4,562 square foot Chick-fil-A drive-thru restaurant and a 2,200 square foot drive-thru Starbucks café. The Project also includes the dedication of approximately 8,600 square feet (±0.2 acres) of land at the southeast corner of the site, just North of Alta Street, to the City of Monrovia for future parkland use. The existing 12,216 square foot restaurant onsite, formerly operated by Claim Jumper, will be demolished. This property is located in the RCM (Retail Corridor Mixed Use) zone. An Initial Study was completed in accordance with the California Environmental Quality Act (CEQA) and a Notice of Intent to adopt a Mitigated Negative Declaration for the project was distributed for a 30-day public review and comment from May 3, 2021 to June 1, 2021.

Recommendation: Adopt Planning Commission Resolutions No. PCR2021-0002 and PCR2021-0003, and recommend City Council approval of Tentative Parcel Map TPM 83202, Conditional Use Permits CUP2021-0006 through CUP2021-0011, and General Plan Conformity Finding GPC2021-0002.
