## Good Evening Councilmembers,

This letter is in regards to the comments that were made last week during the Gascon review. Specifically, I am shocked at the complete "othering" of people who are charged with lowlevel crimes. All, which if actually tried and charged would result in nothing more than a year in jail. Statistically, Black men are charged at higher rates of these crimes when no crime was actually committed. I bring this up specifically because a year ago the council said they wanted to do better and have equity and inclusion, and they go so far as to institute a commision that meets every other week for over 7 months, and yet: when the government and institutions that have perpetuated systematic racism is trying to dismantle those issues, our city council questions if it's really the right move? Councilmember Blackburn speaks condescendingly to anyone who voted for Gascon and tells listeners they need to " reevaluate your values.. consider that the next time you have the opportunity to vote."

As it has been proven time and time again, more jail time is not a deterrent. We need to change the paradigm of punishment, because what we are doing is not working.

What was completely lacking during this conversation on June 15th was empathy. These charges were placed on our neighbors, and possible friends and family members to some of us. They are not "others" they are not people who should be looked down upon. They are Monrovians. They are people who need help, and we as a community should be able to help our neighbors. All that was shown in the report were numbers: not demographic breakdowns, age ranges. Is it possible that we have an entire group of citizens that we are overlooking because we are trying so desperately to be "tough on crime"? What is the breakdown of people who are being targeted? If we take a look at the data, we can possibly come up with solutions as opposed to "it's terrible that no one is in jail." Study after study after study shows that people who go to jail once are more than likely to be caught in a cycle of jail time. That the money spent on jailing does not rehabilitate. Monrovia is already a leader in some of our policing tactics, we can continue to do better and there are a number of programs we could look into such as Alternative Dispatch (PACT in Claremont is a great example). Obviously, there is no this way or that way answer, this is an area with a lot of gray, and we should be working together as a community to help our community be better as opposed to sending everyone to jail. We have options. Let's use them.

## Good Evening Councilmembers,

If the council wishes to move forward with a municipal or special election to switch to a rotating mayor, prior to the vote, I request a study on districting our city. It seems the only reason this conversation is happening is because all elected seats are citywide and no one member holds more power than another.

As we are a small city, but very diverse, it would behove us to have better elected representation of the different areas of Monrovia. This could be done with a citywide elected mayor to serve the original purpose for this designated seat, which was for someone who had the "necessary abilities, time, energy and leadership qualities for such an important office... an elected Mayor will be more responsive to the voters." With four other seats made up of the NE/NW/SE/SW.

If you only talk about moving to a rotational mayor because officials are elected citywide, it is worth exploring the idea of districting our community as well. As you mention in the report, "In some ways, having a directly-elected mayor can be confusing to constituents in a general law city." Many constituents may not even know that districting is an option. Our neighbors Arcadia and Duarte are districted towns and they are not much different than us. Instead of changing one seat, maybe it's time to rethink the whole structure.
