Please ask the developers to go back to the drawing board and figure out a way to preserve the trees along Huntington.

There is a large sycamore tree in front of the proposed development. This tree was planted over 30 years ago and has grown to over 50 feet. It has 3 healthy trunks that are each about 5 feet in circumference. Despite the drought conditions and even with the irrigation turned off for the last year, this tree is still healthy and thriving.

A large healthy tree is a great way to offset the increase in cars that will be added with a drive thru; it also provides shade and reduces expenses for HVAC. This tree matches the existing landscape to the north and west. That tree is not Claim Jumpers' tree; it is Monrovia's tree.

I'm sure the developers plan to replant the area, but it takes 30 years to get a tree that size. They can't replace a mature tree like this, so let's not allow them to remove it. Please encourage them to find a way to preserve this magnificent specimen.

This public comment is in regards to the Huntington Drive & 210 Project.

When I visit a town, I always look for places to eat or shop that are unique, something different and not mainstream.

I'm not a fan of the Starbucks & Chick-fil-a build pending at the 210 x Huntington where the existing Claim Jumper is currently located. While I would rather see another sit down style restaurant occupy the location, I think what bothers me most is another Starbucks. It would be nice and more befitting for Monrovia to have an independent coffee or other small shop/cafe instead of another Starbucks. There are more than enough Starbucks within a 3 mile radius including the one at Huntington x Magnolia, which is a 24 hour operation, not to mention the one at Madison x Foothill which has created and continues to create its fair share of traffic issues.

The face of Monrovia has been slowly changing, as any City does over time. It's called progress I suppose. I like the old town charm that Monrovia offers and declares to be but that charm has slowly been being taken away little by little. It may be imperceptible changes but overtime the results are dramatic and the changes irreversible. The charm and character we know and love will eventually disappear and we will become just another commercial space with no unique characteristics.

I am not sure what the purpose of this public input at this stage is. It's clear that the decision has been made to move forward with the build (initial MND indicates Starbucks has already hired 16 employees). So, what is the benefit of public input at this stage or any stage for that matter other than documentation. It's a David and Goliath situation, one in which I know the "little" guy will not win. Ultimately, I suppose my input is only to pacify my own feelings.

I've read through the initial Mitigated Negative Declaration (MND) study and some of the other documents. I am also aware that the State of California plays a large part of pushing the hand of the City to move forward with any project regardless if the City is interested in a particular business. I also realize that the City may or may not have initially known the name of the restaurants so as to be impartial in the decision process. I've taken all this into consideration in regards to my opinions for this project.

Here are some of my concerns over the Chick-fil-a and Starbucks being built, aka Huntington & 210 Project:

I truly feel that traffic will be an issue for the eastbound lanes of Huntington approaching the 210 onramp as well as an impact to traffic exiting the 210. The peak hours for vehicular traffic, from my observations, are typically lunch and going home hours, causing a backup down Huntington for some distance in both directions. Now we are adding the peak traffic hours of both restaurants, Chick-fil-a in particular, which will add additional traffic to the already busy Huntington peak hour traffic. This will most likely lead to the Chick-fil-a drive thru coming to intermittent standstills from the north facing entry/exit driveway. This may also lead to intermittent back up at the lighted intersection at the Double Tree entry/exit point. Even though there is a plan in place where the City has the authority to dedicate the eastbound lane of Huntington to a right turn only at that center driveway entry/exit point, which I anticipate will be needed after the initial opening traffic wanes, there will still be issues. 2,046 anticipated daily trips to these restaurants will most definitely contribute to increased congestion. The initial MND even documents "two intersections are already operating at unacceptable levels of service (LOS)". Even with the suggested lane improvements the LOS will still be impacted as stated in the studies.

The Final Initial Study/ MND, in response to another public comment regarding late night disruptions, indicates that under the City's general plan, the police department is staffed with 64 sworn regular policeman, 11 reserves and 23 volunteer support staff. These numbers are grossly inaccurate. The police department currently employs approximately

50 officers, 2 reserves and 3 volunteers. As the City expands and new businesses/housing are built, the potential for police response increases yet the staffing levels for patrol officers remain critically low. All these new businesses and housing should incur a fee to employ an additional officer(s) to serve the needs of the public and this new project should be no exception. At minimum, this should be considered for any future builds.

My last concern is the removal of the trees at this project. Monrovia has participated in a tree planting program; 2 trees planted for every 1 removed due to drought or construction. This construction site may not be what the program was referring to but the removal of trees is always unfortunate. Perhaps the City would consider having these two new businesses donate the funds for the 23 trees being removed on a 2 trees for every 1 basis (46 trees worth) in order to fund the current tree planting program or perhaps they can donate the same money for greenscaping another City project that is underfunded. Also, if the trees are destroyed (chipped) on site, can the City re-use the chips for any landscaping projects?

In summary, I'm primarily opposed to the Starbucks café and to the increased traffic snarls that both restaurants will bring.

I appreciate you taking mine and any other comments into consideration.
