Governor Newsom Proclaims a State of Emergency

March 4, 2020

- Governor waives regulations that may hinder response and recovery efforts
- Recovery assistance is made available
- Expedites access to State and Federal Resources
- Issues a variety of health orders to prioritize responses to COVID-19

Residential Eviction Moratorium

- On March 31, 2020, City Council approved an eviction moratorium for residential tenants unable to pay rent as a result of COVID-19 financial hardships, and "no-fault" evictions.
- Tenants are liable for unpaid rent, which the tenant must pay in full within six months following the expiration or termination of the local emergency.
- On June 25, 2021, Governor Newsom extended a statewide residential eviction moratorium through September 30, 2021 (AB 832). County and CDC orders remain in place.
- \$5.2B in federal rental assistance available

Commercial Eviction Moratorium

- On April 7, 2020, City Council approved an eviction moratorium for commercial tenants unable to pay rent as a result of COVID-19 financial hardships, and "no-fault" evictions.
- Tenants are liable for unpaid rent, which the tenant must pay <u>in full</u>
 within six months following the expiration or termination of the local
 emergency.
- On June 25, 2021, Governor Newsom extended the statewide residential eviction moratorium through September 30, 2021 (AB 832) which also repealed local governments' statutory authority to impose commercial eviction moratoria.

Public Meetings

- Upon declaring a local emergency in Monrovia, all board and commission meetings were cancelled and non-essential agenda items for City Council were postponed.
- On March 17, 2020, the City held its first virtual City Council meeting to protect the health and safety of the public and staff. Other Boards and Commissions have met virtually.
- After September 30, 2021, local public agencies must transition back to in-person meetings held in full compliance with the Brown Act
 - During the pandemic, local legislative bodies were authorized to hold public meetings via teleconference and some of the legal requirements for teleconference meetings under the Brown Act were waived
- Council may resume in-person meetings prior to September 30

Reopening of California- June 15, 2021

- Governor Newsom terminated some executive orders that put into place the Stay Home Order and the Blueprint for a Safer Economy
- Phased out a number of executive actions
- Restrictions that ended on June 15
 - Physical distancing
 - Capacity limits on business
 - County Tier system
- Places of Work- Cal OSHA's Emergency Temporary Standards
 - New requirements for face coverings
 - Vaccination
 - Close Contact
 - Employee Training



Reopening of California- June 15, 2021

- Los Angeles County Department of Public Health lifted mask requirements for vaccinated individuals, while unvaccinated people must wear a mask indoors in public settings
 - Subsequently "recommends" mask wearing for all in indoor public settings
- California no longer has a travel advisory in effect
- Indoor events with 5,000+ people must confirm proof of vaccination or negative COVID-19 status
- Outdoor events with 10,000+ people, it is recommended that attendees confirm proof of vaccination or negative COVID-19 status
