CLOSED SESSION: Mayor Tom Adams convened the Special Meeting / Closed Session of the Monrovia City Council on Tuesday, January 19, 2021, at 6:00 p.m., to discuss: CS-1 Conference with Real Property Negotiator pursuant to Government Code §54956.8; 228 West Pomona Avenue, Monrovia, California; City Negotiator: City Manager; Negotiating Parties: Catalyst Housing, California Community Housing Agency (CalCHA), Parks at Monrovia Station Square I LLC dba Legacy Partners, Inc.; Under negotiation: Terms of City's possible acquisition of an option to purchase the subject property.
