Question: Who are the unidentified partners in this enterprise other than retired Monrovia Police Chief Roger Johnson? Answer: Retired Monrovia Police Captain Donald Lacher and retired Arcadia Police Chief Robert Sanderson.

Private investigating is a lucrative endeavor for retired police officers to supplement their meager pensions by tapping into easy money available from their former departments. It's kind of a revolving door. This concludes my report of some preliminary findings. I urge the Council to reject the agreement and explore other options. Perhaps there are unretired employees who could perform these background checks if they are not already overworked. If that is not feasible, perhaps the job could be farmed out to a private investigator with no incestuous ties to the police department, thus avoiding any appearance of nepotistic cronyism.
