MINUTES OF THE SPECIAL AND REGULAR MEETINGS OF THE MONROVIA CITY COUNCIL HELD TUESDAY, AUGUST 3, 2021, 7:30 P.M.

AN ORDINANCE OF THE CITY OF MONROVIA, CALIFORNIA, ADOPTING ZA2021-0001, A ZONING ORDINANCE AMENDING SECTION 17.16.050 OF TITLE 17 (ZONING) OF THE MONROVIA MUNICIPAL CODE TO ELIMINATE THE MINIMUM BUILDING HEIGHT STANDARD OF TWO-STORIES, TO CORRECT INCONSISTENCIES REGARDING DENSITY AND FLOOR AREA REGULATIONS, AND TO ALLOW MINOR DEVIATIONS FROM THE LOT SIZE AND DEVELOPMENT STANDARDS WHEN A PROJECT SUPPORTS THE INTENT OF THE RETAIL CORRIDOR MIXED USE (RCM) ZONE AND THE PLANNING OBJECTIVES ARTICULATED IN THE MONROVIA MUNICIPAL CODE AND MONROVIA GENERAL PLAN LAND USE ELEMENT FOR THE (RCM) COMMERCIAL ZONE
