

Highlighted Activity for November 18 - November 23, 2021

Drug Activity - Suspect Arrested

November 18 at 12:58 a.m., officers were patrolling a vacant lot in the 1600 block of S. Magnolia when they located a male subject loitering on the property. An investigation revealed he was in possession of a controlled substance and drug paraphernalia. He was arrested.

Court Order Violation – Suspect Arrested

November 18 at 1:19 p.m., a resident in the 900 block of W. Hillcrest called to report that her ex-husband drove past her house, violating a domestic violence restraining order. Officers arrived and completed a report. The ex-husband came into the Monrovia Police Department lobby a short time later and provided a statement. He was arrested and taken into custody.

Public Intoxication – Suspect Arrested

November 19 at 2:12 a.m., officers responded to the 200 block of W. Lime regarding a male subject laying in the middle of the alleyway. Officers contacted the subject who was heavily intoxicated. It was determined he was unable to care for himself. He was arrested and transported to the Monrovia PD Jail for a sobering period.

Weapon's Offence

November 19 at 4:42 a.m., a caller in the 1500 block of Encino advised that as he was arriving home he saw a suspect going through his mailbox. The suspect then got into the passenger's seat of a white vehicle. The caller followed the vehicle through the neighborhood before the suspect brandished a firearm. The caller then stopped following the suspect vehicle. This investigation is continuing.

Injury Traffic Collision

November 19 at 8:23 a.m., a witness reported a traffic collision occurred in the intersection of Ivy and Walnut. Officers arrived and checked on the well-being of the occupants. One of the drivers injured her arm and was transported to a local hospital.

Vandalism

November 19 at 8:58 p.m., a vehicle vandalism was reported at the 1200 block of S. Alta Vista regarding. An investigation revealed that a large rock had been thrown through the front windshield. This investigation is continuing.

Mental Evaluation

November 20 at 11:20 a.m., a caller advised that she had just spoken with someone in the 200 block of E. Maple who expressed an interest in harming herself. Officers located the female subject and determined that she needed to be evaluated by a mental health professional. She was transported to a local facility for treatment.

Drug Activity - Suspects Arrested

November 20 at 1:00 p.m., a suspicious parked vehicle was reported near the intersection of Lemon and Parkrose. The vehicle was occupied by two subjects. Officers arrived and made contact with both subjects. An investigation revealed they were both on probation for narcotics. They were also found to be in possession of drug paraphernalia. They were arrested.

Assault

November 20 at 6:36 p.m., officers responded to an apartment in the 100 block of W. Olive regarding a fight between two sisters. During an argument, one of the sisters hit the other over the head with a glass bowl, cutting the other's head. The suspect fled the area before officer's arrival. The remaining sister was transported to a local hospital for her injury. This investigation is continuing.

Weapon Offense

November 20 at 9:17 p.m., three female victims called 911 saying they were being held inside a vehicle by a male suspect with a knife, near the intersection of Myrtle and Pomona. The vehicle with the three females was located and an investigation revealed that the suspect was related to the three females. They had been in a verbal argument before he threatened them with a knife. The suspect fled the area on foot. This investigation is continuing.

Traffic Collision / Driving Under the Influence - Suspect Arrested

November 20 at 10:03 p.m., a traffic collision was reported in the 3000 block of S. Peck. Upon arrival they saw that one of the drivers was displaying the signs and symptoms of being under the influence of alcohol. A DUI investigation was conducted and that driver was ultimately arrested and transported to the Monrovia PD jail for booking and a sobering period.

Traffic Collision / Driving Under the Influence

November 21 at 1:40 a.m., a traffic collision in the 400 block of W. Huntington was reported. A vehicle hit a sidewalk and tree before catching on fire. Upon arrival, officers noticed that the driver was heavily intoxicated. He was transported to a local hospital for treatment and a blood sample. This investigation is continuing.

Drug Activity – Suspect Arrested

November 21 at 9:07 a.m., several residents in the 300 and 400 block of Norumbega reported an adult male, barefoot, walking along the middle of the street. Officers contacted the subject and found he was in possession of drug paraphernalia. He was arrested and taken into custody.

Vehicle Burglary

November 21 at 9:07 a.m., a resident in the 1100 block of S. Fifth arrived home after a few days on vacation and discovered someone had forced entry into her parked vehicle. Personal property was stolen. This investigation is continuing.


Monrovia's Safe Schools Anti-Violence Reward – \$100 CASH
