# NEIGHBORHOOD WATCH REPORT



## Highlighted Activity for December 9–15, 2021

### **Traffic Collision / Hit and Run**

December 9 at 8:04 a.m., a City of Monrovia employee was driving a city vehicle in the 700 block of S. Myrtle when someone rear-ended her and drove away. The employee was not injured. This investigation is continuing.

### **Elder Abuse**

December 9 at 11:02 a.m., the Monrovia Fire Department reported a possible elder abuse victim was located at the 600 block of S. Shamrock. Officers responded and determined that financial abuse was likely occurring. The victim was a dependent adult who was homeless. This investigation is continuing.

### **Drug Activity / Resisting Arrest – Suspect Arrested**

December 9 at 8:24 p.m., officers responded to the 1100 block of Orange regarding a suspicious person possibly under the influence of drugs. The subject was seen swaying back and forth and talking to himself. Officers detained the subject and an investigation revealed he was in possession of drug paraphernalia. He was arrested and transported to the Monrovia PD Jail for booking and a sobering period.

### **Medical Assist**

December 10 at 11:52 a.m., an elderly male was walking in the area of Royal Oaks and Mountain when he slipped and fell on the sidewalk causing an abrasion to his forehead. Paramedics responded and treated the subject at the scene.

### **Domestic Violence – Suspect Arrested**

December 10 at 5:06 p.m., a female subject called to report she was assaulted by her ex-girlfriend in the 800 block of S. Myrtle called. During an argument the ex-girlfriend struck the victim with a cutting board. Officers responded and conducted an investigation. The ex-girlfriend was arrested and taken into custody.

### **Traffic Collision**

December 10 at 8:00 p.m., officers responded to the 700 block of E. Lemon regarding a traffic collision between a motorcycle and a vehicle. When officers arrived they discovered

the motorcyclist tried to pass on the left as the vehicle began making a left turn into a driveway. The motorcyclist was thrown from the vehicle onto the street. The motorcyclist was seen by paramedics, but sustained no injuries. He was cited for driving without a license and his motorcycle was stored.

### **Grand Theft Auto**

December 10 at 11:12 p.m., a caller reported that her vehicle was just stolen in the 1800 block of S. Peck. Her husband went out to chase the suspect in his vehicle. Officers responded and while enroute were told the husband had located the vehicle and confronted the suspect who abandoned the vehicle and fled on foot. An area search was conducted, but the suspect was not located. This investigation is continuing.

### **Critical Missing / Mental Evaluation**

December 11 at 2:23 a.m., a female caller reported she and her boyfriend had recently broken up and he told her that he wanted to kill himself. Officers responded to the subject's home in the 700 block of S. Mayflower, but he was not there. An investigation revealed the subject had gone to a bridge in San Pedro. Los Angeles Police Department was notified, but the subject left before officers arrived. The subject returned home and officers contacted him there and determined he needed to be evaluated by a mental health professional. The subject was transported to a local facility for treatment.

### **Bicycle Theft**

December 11 at 8:37 a.m., a victim in the 1100 block of S. Fifth called to report his mountain bike was taken from his locked onsite storage unit. The bike was taken sometime during the last two weeks. An investigation revealed the bike was at a location in Altadena. Detectives responded to the location and recovered the bicycle from a subject who had recently purchased the bicycle on Offer Up. The bicycle was returned to the owner. This investigation is continuing.

### **Mail Tampering**

December 11 at 11:07 a.m., a resident in the 400 block of Meadow called to report that he found someone else's mail in his mailbox. He had video footage that showed a mustang pull up to his mailbox, the driver gets out and places several pieces of mail into his mailbox, then drives away. The mail belonged to a resident in the 700 block of Mountain View. This investigation is continuing.

### **Medical Assist**

December 11 at 12:16 p.m., an elderly male subject was walking in the 500 block of S. Myrtle when he lost his footing and fell. He sustained bruising and a small cut on his face. Paramedics treated him at the scene, but he declined to go to the hospital.

### **Threatening**

December 11 at 5:03 p.m., a female subject in the 600 block of Gladys called to report that her ex-husband called her and told her that he wanted to kill her. She wanted information on how to obtain a restraining order. This investigation is continuing.

### **Domestic Violence – Suspect Arrested**

December 12 at 2:31 a.m., a female subject in the 1800 block of S. Peck called to report an altercation had just occurred between her daughter and her daughter's boyfriend. Officers arrived and discovered the daughter and boyfriend had been drinking and got into an argument when they arrived at the residence. The boyfriend then started throwing things around the house and punched the girlfriend causing her to fall to the ground. She sustained minor injuries. The boyfriend was arrested and taken into custody.

### **Traffic Collision / Hit and Run**

December 12 at 7:01 p.m., a delivery driver was traveling south on Canyon and made a turn onto Chestnut, striking a stop sign. The driver exited the vehicle to look at the damage and fled. According to a witness there was a male driver and female passenger in the vehicle. This investigation is continuing.

### **Disturbing Subject**

December 12 at 8:30 p.m., a customer at a restaurant in the 100 block of W. Duarte purchased food for a male subject. The subject received the order and became upset when he realized that there were only two sandwiches inside. The subject went outside and threw a rock at the front glass door and threatened to return at a later time. Officers located the subject and advised him he was no longer allowed at the business. The business did not desire prosecution.

### **Death Report**

December 12 at 9:28 p.m., a caller in the 300 block of N. May reported she arrived at the home and found her mother unresponsive. An investigation revealed that the death appeared to be from natural causes.

### **Missing Person – Missing Located**

December 13 at 1:06 a.m., a female caller reported that she was being held against her will in the 1700 block of S. Mayflower. Officers responded to the area and conducted door knocks, but were unable to locate her. The female was added to the Missing Person System. After an intensive investigation involving officers from the Los Angeles Police Department the female was located in Monrovia and advised she was fine. This investigation is continuing.

### **Commercial Burglary**

December 13 at 1:17 a.m., officers responded to a business in the 1900 block of S. Myrtle regarding an alarm notification. Upon arrival they discovered the suspect(s) removed the iron security gate and made entry into the front part of the business. The loss is unknown at this time. This investigation is continuing.

### **Drug Activity / Warrants – Suspects Arrested**

December 13 at 9:42 a.m., officers responded to the 500 block of W. Huntington regarding several subjects loitering in the area. They were contacted and an investigation revealed they had multiple warrants for their arrest. They were also found to be in possession of a controlled substance. Both were arrested and taken into custody.

### **Threatening**

December 13 at 12:32 p.m., a female subject in the 300 block of E. Palm reported that her ex-boyfriend had threatened to shoot her and her house. The threats were made via text message. This investigation is continuing.

### **Vandalism**

December 14 at 1:53 p.m., officers responded to a vandalism at a business in the 900 block of W. Huntington. An investigation revealed there had been a confrontation at the business between two employees. One employee left and threatened to return and slash the tires of the other involved employee. A short time later the victim found his tires slashed. This investigation is continuing.

### **Injury Traffic Collision**

December 14 at 2:51 p.m., officers responded to a traffic collision that had just occurred near the intersection of Foothill and Mayflower. One vehicle rear ended another that was stopped at a red traffic signal causing a chain reaction involving a total of four vehicles. Paramedics responded and transported multiple subjects to a local hospital for treatment.

### **Grand Theft**

December 14 at 6:23 pm, a victim reported that sometime that day someone stolen his Honda Accord's catalytic converter while it was parked in a parking lot in the 400 block of E. Huntington. This investigation is continuing.

### **Mental Evaluation**

December 14 at 8:15 pm, a caller reported that her son was suicidal and had locked himself in the bathroom of their residence in the 600 block of W. Olive. Officers responded and were able to make contact with the son. It was determined that he was a danger to himself and needed to be evaluated by a mental health professional. He was then transported to a local facility for treatment.

### **Public Intoxication – Suspect Arrested**

December 15 at 8:47 a.m., officers responded to a hotel in the 700 block of W. Huntington regarding a 911 hang up. Upon arrival officers were advised of an intoxicated subject on the fourth floor. Officers contacted the subject and determined he was too intoxicated to care for himself. The subject was arrested and transported to the Monrovia Police Department Jail for a sobering period.

### **Domestic Violence – Suspect Wanted**

December 15, 7:31 pm, a guest at a hotel in the 900 block of S. Fifth reported that a possible domestic violence had just occurred in a neighboring room. Officers arrived and contacted the female victim. She had been in an argument with her boyfriend and when she tried to leave, he blocked her path and assaulted her. The male fled shortly thereafter. Officers checked the hotel and the parking lot but the male was not found. A WANTED was issued for his arrest. This investigation is continuing.
