Dear City Clerk,

I would like to submit my comment in reference to the above agenda item for the City Council meeting of 02/01/2022. Specifically I would like to express, in the strongest possible terms, that suspending the Temporary Outdoor Business Operations (TOBO) permits at this time would be severely detrimental to my business operations.

I own and operate Wingwalker Brewing at 235 West Maple Ave. in town. There are additional factors that apply to all of the breweries in town that are not mentioned in the staff report. These are:

1) Breweries are especially prohibited from serving patrons indoors unless they can produce a valid vaccination card. We are subject to random inspection and severe fines if we do not enforce this requirement. Restaurants are not required to enforce a similar restriction; it is merely "suggested" that they do so.

2) All of the breweries that conducting business under the TOBO permits are doing so on private land, not public spaces and not in areas where the outdoor operations directly impact area businesses. Since the specific issue raised by the MOTAB (Monrovia Old Town Advisory Board) is the unfair advantage enjoyed by TOBO permit holders benefiting from the use of public spaces I am asking if an exemption to the permit suspension could be made for those businesses not located either on Myrtle Avenue or in Old Town proper.

3) I believe the staff conclusion that there will be no fiscal impact from suspending TOBO permits to be inaccurate. While there will certainly be no direct cost, the informal information I have from my patrons indicate that 30-50% of them are not yet comfortable with indoor events or dining and would choose not to go out if the option for outdoor patronage is not available.

Thank you for this opportunity to contribute. I hope the Council is understanding to the needs of businesses outside of Old Town in this matter.

Dear City Council Members,

In regards to the agenda item : Recommendation from Monrovia Old Town Advisory Board (MOTAB) to Suspend Temporary Outdoor Business Operation (TOBO) Permits

Having read through the report prepared by Tina Cherry, the recommendation to suspend TOBO permits stems from issues that MOTAB members have with businesses in Old Town, particularly those utilizing public property at no cost to benefit their private businesses.

This recommendation is NOT in relation to the 4 non-TOBO holders who are not MOTAB members. Our business, for example, utilizes the TOBO and it has been one of the only ways in which we could garner reasonable revenue (we're not even back to pre-pandemic levels) to operate a business. Without the TOBO, we will have to shut down.

The problems that MOTAB members are raising are not relevant to our business at all. We do not operate our outdoor business on public property, we do not enjoy the use of public property for our own personal benefit, and we do not compete with MOTAB businesses for Old Town customers.

We ask that the Council consider the ramifications of suspending the TOBO on other Monrovia businesses besides MOTAB businesses and if only the MOTAB businesses seek a suspension, then allow non-MOTAB businesses to continue operating with their TOBO permits. Allow TOBO holders who operate on their own private property to continue.

Shutting down our business would drive out over \$2 million dollars in capital investment not to mention the tax dollars that we send to Monrovia every year and having to lay off the skilled labor we hire.
