Measure K Roadshow Results

- 239 responses from Monrovia community members
- Nearly 500 different recommendations to spend \$15m!

Staff Review of Outreach

- Many suggestions are included multiple times.
- Staff is organizing suggestions into 5 different categories
 - Tier 1 Current and Happening (43 Recommendations)
 - Tier 2 Established Need or Project (160 Recommendations)
 - Tier 3 Future, Not Ready or Additional Planning Required (269 Recommendations)
 - Tier 4 Infeasible or Unlikely to Happen (2 Recommendations)
 - Other Miscellaneous feedback



Tier 1 Projects – 43 Recommendations

- Huntington Drive Monument Signage
- Funds go to police officers and firefighters where needed
- Bike racks on Myrtle Avenue
- Shade coverings at Library Park (may have a funding gap)
- More pressure washing in Old Town



Tier 2 Projects – 160 Recommendations

- Pedestrian Safety Improvements
 - Signaled crossings around schools
 - New turn signals (various locations)
 - New designated crosswalks
- Implement Bike Master Plan
- Community Center Renovation
- Upgrades at Recreation Park



Tier 3 Projects – 269 Recommendations

- Prepare for rising temperatures and climate change
- Place utilities underground
- Add new sidewalks in certain areas
- Community Land Trust (unaware of RHT)
- Business loans to those affected by the pandemic
- Splash Pad
- Affordable Housing Projects
- Safe Overnight Parking Lots (for those living in vehicles)
- Repave & refurbish alleyways



Tier 4 Projects – 2 Recommendations

- Convert Monrovia Market and Overton Moore buildings to affordable housing
- Place 4 pickleball/tennis courts on top of reservoir on Mountain Avenue



Other

- Money should be spent for benefit of all Monrovians without regard to income level
- Draft a methodology to ensure money is spent in equitable way
- "Why tax people, then dream up ways of spending the money?"



Citizen input for consideration

- Seek projects that have "payback" to reduce ongoing costs
- Invest in broadband infrastructure
- Community grants awarded by Committee
- Apportion funds using an allocation methodology
 - Target projects that benefit lower-income, at-risk individuals
- Maintain a Measure K reserve
- Use Measure K for matching grant funds



Council Discussion Items - 2/1/22 Meeting

Mayor Adams

- Do not commit to ongoing costs
- Complete one-time projects

Council Member Shevlin

- We should leverage Measure K to seek other funding sources
- Increase reserves for ongoing capital and maintenance costs

Council Member Spicer

Prioritize the 5-year CIP...must be fully funded



Council Discussion Items - 2/1/22 Meeting (Cont.)

Mayor Pro Tem Crudgington

- Must not use funds to start ongoing programs
- Prioritize City's basic functions/needs

Council Member Blackburn

 Use a combined approach to fund priorities (Measure K and other revenues)

Principles of Financial Management

PRINCIPLE I CITY BUDGETS MUST BALANCE

The City Council will continue to adopt balanced budgets on an annual basis. Annual audited financial reports confirm the adoption of a balanced budget, and note any discrepancies. These financial reports are used by the financing community to gauge the City's credit

worthiness, among other issues.

PRINCIPLE II THE CITY SHALL MAINTAIN PRUDENT RESERVES

Adequate reserves of funds shall be established to meet future capital needs, to offset economic hard times, to stabilize fluctuations in cash flow requirements, and to provide for emergency situations, consistent

with the City's Reserve Policy.

PRINCIPLE III THE CITY SHALL ENDEAVOR TO MAINTAIN COMPETITIVE

COMPENSATION

The City wishes to continue positive labor relations, be competitive in the market place, and desires to attract and retain top talent Competitive salary and benefits will be provided to all employees within the City's means, with the expectation that services being provided by staff will continue to be exemplary.

PRINCIPLE IV THE CITY SHALL MAINTAIN ITS INFRASTRUCTURE

Ongoing, preventative maintenance is an essential component of the City's operations. Adequate funding shall be allocated in current years to minimize expenditures in future years. Infrastructure maintenance includes, but is not limited to, streets, sewers, storm drains, water systems, sidewalks, lights, and parks.

PRINCIPLE V THE CITY SHALL AMORTIZE CAPITAL COSTS

To the extent possible, the cost of replacing or expanding existing facilities and equipment will be fully amortized as a continuing cost of doing business. With respect to equipment, rates shall be established to recover the replacement cost of each item at the end of its useful life. Facilities will be amortized to cover ongoing maintenance and cyclical repairs, and for the replacement or expansion of major
