

FREQUENTLY ASKED QUESTIONS

WHAT IS THE PURPOSE OF THE C&D PERMIT APPLICATION?

The purpose of the C&D permit application is to ensure compliance with diversion requirements as stated in MMC 8.09.050. The City of Monrovia requires that all covered projects shall divert at least 50% of the total construction and demolition debris generated, unless approved for exemption.

WHAT IF I HAVE A SMALLER SCALE PROJECT?

If your project is less than 1,000 square feet, you still need to dispose of and recycle your C&D material. To do so, please contact Athens Services to arrange for services and costs.

CAN I CHOOSE ANY HAULER?

Monrovia residents shall use Athens Services for all disposal and recycling requirements for residential and commercial construction. DO NOT use any other hauler as the City of Monrovia is exclusively contracted with Athens Services.



C&D RECYCLING PROGRAM CHECKLIST (≥1,000 SQ. FT.)

- Pick up** C&D Recycling Program Permit Application Packet from Public Works
- Submit** waste Management Plan to Environmental Services at Public Works
- Pay** Performance Security Deposit of \$0.20/square foot of floor area (minimum \$250.00 deposit)
- Provide** a Waste Management Report at end of construction stating final summary of diversion.

WHAT TO DO

BEGINNING CONSTRUCTION

If you are planning on completing construction in your home, make sure to think of a plan for your construction and demolition debris. If you're not sure if you need a permit or need more information, call the Building Division at (626) 932-5581.

OUR GOAL

Our goal is to ensure that at least 50% of construction and demolition debris generated by any project is diverted.

LEED Certification: If you need to demonstrate 75% of greater diversion, please let Athens Services know when you are requesting services.

WHAT IS CLASSIFIED AS C&D MATERIAL?

C&D material is classified as any material that is used or discarded resulting from construction, remodeling, repair, or demolition operations on any pavement, residential or commercial building, or other structure.

C&D RECYCLING PROGRAM

Please fill out a C&D Recycling Program application if you meet one of the eligible requirements listed below. Application checklist listed on back of brochure

1. Residential addition of 1,000 square feet or greater
2. Renovation improvements of 1,000 square feet or greater
3. New construction of 1,000 square feet or greater
4. Demolition of 1,000 square feet or greater

ANY RESIDENTIAL CONSTRUCTION

If you are planning construction of any size, please contact Athens Services for cost and rental of roll-off bins. Any roll-off/bin rentals must be purchased through Athens Services.

OPTIONS

CONSTRUCTION AND DEMOLITION DEBRIS RECYCLING



Reuse construction material that is in good condition onsite



Consider donating materials to Habitat for Humanity for reuse.



Participate in C&D Recycling Program to haul construction and demolition debris to a recycling facility.



Contact the City's Solid Waste Provider, Athens Services at (888) 336-6100 for rental and disposal costs, and then request delivery of construction and demolition roll-off.

Please Note: Prior to delivery of C&D roll-off, a resident or contractor must obtain an Encroachment Permit from the Public Works Department, if the roll-off will be placed in the street or within the public right of way. You must provide proof of insurance that indemnifies the City of Monrovia. For more information contact the Public Works Department.
