Hello,

I wanted to comment, as a resident of MODA at Monrovia Station, regarding Resolution No.2022-12 on parking on West Pomona Ave. As a resident, the parking outside of the unit has never been congested, not once. I have always been able to find parking available on the street regardless of the time of day. I'm unsure of where this issue of congestion comes from; the only thing I can think of is when the metro comes by, but that only affects congestion on West Magnolia, not West Pomona.

After living here for over 2 years, the traffic (or parking for that matter) has never been an issue. Suddenly, these permanent no parking signs go up and I notice congestion. Congestion created by now suddenly restricting parking on a single street. The issue that I never saw was suddenly created on the surrounding streets. This, coupled with the parking restrictions of the construction going on at West Magnolia has only made the problem worse.

We're talking about parking restrictions on a street that's 0.1 miles long; this street is used by residents and guests of this building. No other businesses around us use this street, and, as I have stated before, if people were parking on this street for the metro it has never been an issue... even from back when this resolution was proposed. What needs to be defined here is congestion, if that's what this whole resolution is based on. If the terms of congestion have never been met, as I have never had an issue day or middle of the night finding parking on this street, then what are these signs here to do?

Parking restrictions were also put on Moda back in January to help make sure those who used the Metro were not parking in our parking structure. It was to make our community safer. I'm sure the resolution that was proposed to you was from a single resident (as was informed to me) and not the several hundred others that live here.
