TITLE: Canyon Park and Hillside Wilderness Preserve Patrol Update for April 2022.

OBJECTIVE: To provide an update on incidents, maintenance, and public comments related to Canyon Park and the Hillside Wilderness Preserve (HWP) recorded for the month of April 2022.

BACKGROUND: For over a century, Canyon Park has been used as a recreational park by visitors and Monrovia residents. Services in Canyon Park include special events; Naturalist led night hikes, interpretive tours, a Nature Center, trails, a waterfall, and views of the San Gabriel Valley. In addition, Naturalists and volunteers maintain the trail systems and facilities.

In 2016, the City opened over 4.5 miles of HWP trials providing passive recreational opportunities for the community. Park Naturalists patrol the HWP and urban parks two times a day by vehicle, utility terrain vehicle and foot. Park Naturalists also respond to calls related to Monrovia's Smoking Ban Ordinance.

In Septmber 2020, the Bobcat Fire forced the closure of Canyon Park and HWP for an extended period of time, as the areas were unsafe and significant repairs were needed.

Due to minimal damage in HWP following the Bobcat Fire, the trail systems reopened on November 16, 2020. Limited hiking opportunites in San Gabriel Valley such as Canyon Park, Sturdevent Falls, Hwy 39, and Eaton Canyon has increased amount of daily visitors to HWP, primarily in Ridgeside and Cloverleaf access points.

Staff worked digently to repair trails and remove hazards in an effort to open Canyon Park as soon as possible. On August 30, 2021 Canyon Park was reopened to the public through a reservation system to ease visitors back into the Park. Staff continue to work on remediating potential hazards and improve trail conditions for Park users. Future wind and rain events may temporarily close the Park as needed to improve safety conditions for Park users.

In addition, following the Fire, the Burn Emergency Area Respose (BEAR) report from the US Forest Service Department showed potential rainfalls could create heavy mud and debris flows in Canyon Park and HWP. Staff is prepared to handle each incident on a case by case basis and will assess damamges and coordinate repairs as needed.

The first significant rain event following the Bobcat Fire occurred on December 13, 2021. This strong storm event brought heavy rain to the LA County area on the evening of Monday, December 13 and continued through Tuesday, December 14. LA County Department of Public Works issued a Phase 2 Debris and Mudflow Forecast.

The National Weather Service reported that the event accumulated over 5 inches of rain which caused significant damage to Canyon Park. Monrovia Canyon Park will remain closed indefinitely as we work to make the needed respairs. During the closure, photos, aerial footage, and much more information will be shared with the community on the City website.

Staff has been intimately involved with clean up and rehbiliation towards Canyon Park roads, trails and infrastructure. Over the next several months Staff will continue to assess and identify damages from the December 2021 rainstorm clean up, identify infrastructure repairs, and oversee the possibilities of upgrades to Canyon Park.

ANALYSIS: During the month of April 2022, Canyon Park Volunteers and Park Naturalists completed 121 hours of maintenance in Canyon Park, Maintenance performance that included clearing debris on the hiking trails, building retention walls preventing trail erosion, and cutting up trees and limbs that fell on the trail.

During the month of April, Management Career Solutions (MCS) assisted with post fire recovery in Canyon Park and Hillside Wilderness Preserve (HWP). Recovery efforts include ash and debris removal that fell on the trail, cutting up trees that fell on the trail, and erosion midigations. Staff is continueing to monitor the progress of work as they assit in Canyon Park and HWP's post fire rehabilitation.

April - Clean up of mud and debris began in Canyon Park. Pokrajac Contractors began the initial phase of the Canyon Park rehabilitation. Contractors are in the process is cleaning debris, boulders, and fallen trees off the main road, repairing trail access, clearing cluverts and working on minor repairs to water system to regain usage in the park.

April 5 – Staff presented a show and tell program for Sunshine Company. Staff engaged with particapants and taught them about the differnet wildlife in Canyon Park and Hillside Wilderness Preserve.

April 7 – Stefin Bank a member of Boy Scout troop 66 met with Staff to discuss a potential Eagle Scout project for the Canyon Park Entry Station. This initial step will be the first of many on Stefin earning his Eagle Merit by creating a more welcomeing Ranger Station for staff, volunteers and visitors.

April 9 – Park Natrualist assisted with the Spring Egg Hunt and Healthy Kids Day Event at Recreation Park. The event provided a fun and safe way to celebrate the spring holiday. Staff helped with the egg hunt, a toddlers fun zone, and many other features for visitors and participants to enjoy.

April 20 – Staff, City Departments, and Park Naturalists hosted an Earth Day at Library Park. Partipants were able to learn about water conservation, partake in a nature scavenger hunt, create nature inspired crafts, and learn about the wildlife in Canyon Park.

April 27 – Canyon Park Staff and Public Works met with West Coast Arborist to identify the risk assessment with perished trees along the Canyon Park roadway and hiking trails that would potentially have to be removed for public safety.

RECOMMENDATION: Staff recommends the Community Services Commission move to receive and file CC-2, Canyon Park and Hillside Wilderness Preserve Patrol Update for April 2022.
