Dear Honorable members of the Monrovia city council,

On the agenda this evening is a discussion for a possible appointment to the council.

I wanted to be there in person, but unfortunately my schedule did not allow me to be in 2 places at once.

The issue before the council is very important and one I know each of you will deliberate with the best possible outcome for our city. That is a given.

Part of what I would like you to know is I have been in your shoes, and in your, seat concerning this very same issue. There will be no shortage of advice from people who are looking to help sway your decision one way or the other, and I am no different.

You will likely here the words "will of the people" with respect to the election outcome. I assure you the "will of the people" was heard loud and clear by you who sit on the dias. There were very clear rules on the ballot which stipulated just how many votes for each position a voter was allowed to cast. One vote for mayor, and two votes for city council. A few days ago the "will of the people" was carried out when Mayor Shevlin, and Councilmembers Spicer and Dr. Kelly were sworn into office. That was the will of the people.

All other candidates who were not elected, no matter how many votes they received, can argue they were somehow intended to become a part of the council body.

That decision is now left up to you all. The burden of office starts now. As I'm sure, the city attorney has laid out the options based on state law. I would suggest we not go through the added expense of a special election. In the uncertain times ahead every dollar in the treasury needs to be maximized to the highest and best use for the community. Running a very expensive election on the heals of an election that is barely 6 weeks old may not be the wisest use of funds. Given this I would hope the council would use the power, given to you by law, and appoint a member of the public for the remaining term vacated by Mayor Shevlin.

If appointment is the direction the council chooses I would like to recommend Sergio Jimenez. Sergio has dedicated a tremendous amount of his adult life helping to make the lives of Monrovian's better. Sergio has been a servant leader for years. He has helped keep Monrovia's past protected by being a member of the Historic Preservation Commission where his record is proof of his dedication to Monrovia's architectural history. He serves with the Volunteer Center for the San Gabriel Valley, and serves with the Monrovia Latino Heritage group. In short, Sergio did not show up a few months before an election and offer his services. Instead he, and his family, showed up generations ago and have volunteered and served our community helping to make Monrovia the place we all call home.
