MATTERS NOT ON THE AGENDA should be presented during the time designated as "PUBLIC INPUT." By State law, the Planning Commission may not discuss or vote on items not on the agenda.

MATTERS ON THE AGENDA: If you wish to address the Planning Commission on a matter on the agenda, please wait until the Chair opens the public hearing or calls for public comment on that matter. For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

AGENDA ITEMS: The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

Request: Approve a Conditional Use Permit to construct a new In-N-Out Burger restaurant with drive-thru service in the Huntington Oaks Shopping Center. The subject property is located in the CRS (Regional/Sub-regional Commercial) zone. Determine that the project is Categorically Exempt (Class 3) pursuant to the California Environmental Quality Act (CEQA).

Request: Consider recommending City Council approval of the Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program and the adoption of the Focused General Plan Update to include the 2021-2029 Housing Element Update, the new Environmental Justice Element, and the Safety Element update. An Initial Study was completed in accordance with the California Environmental Quality Act (CEQA) and a Notice of Intent to adopt a Mitigated Negative Declaration for the project was distributed for a 30-day public review and comment period beginning on September 1, 2022 and ending on October 3, 2022.

Recommendation: Adopt Planning Commission Resolution Nos. PCR2022-0005, PCR2022-0006, PCR2022-0007, and PCR2022-0008 recommending City Council approval of the Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program and adoption of the Focused General Plan Update
