AR-1 Teen Advisory Board (TAB) Evaluation – Amanda Carey, Youth Librarian provided the Board with an evaluation of the Teen Advisory Board (TAB). The board was established in 2009 and serves grades 6th through 12th. Teen Advisory Board involvement allows students to gain leadership skills through program planning and volunteer opportunities within the City and library. There are currently 85 teen members that have contributed a total of 717 volunteer hours and saved the library \$10,820 in fiscal impact. Most of the members are made up of Monrovia High School (48%) and are 11th graders (24.7%)

Teen Advisory Board (TAB) partnered throughout the year with Youth Commission on the events such as the Spring Egg Hunt, Make a Difference Day, Monrovia Duarte Black Alumni Association (MDBAA) Luncheon, Children's Art Festival, Earth Day Scavenger Hunt, Arber Day, Lego Day, Halloween Maze and more. Teens enjoyed fun programs such as Laser Tag, teen crafts, and STEAM kits.
