#### ADMINISTRATIVE REPORTS:

## AR-1 MISC2022-0014 Miscellaneous Review; 127 West Pomona Avenue, Robert Montano for Adept Development, Applicant

Senior Planner John Mayer presented the staff report and answered questions of the Development Review Committee regarding street parking and emergency vehicle access, along with questions about maintenance of the outdoor furnishings and landscaping.

Public Input:

1. Brian Yamaguchi, Monrovia resident, spoke with concerns related to the proposed water feature and safety concerns, adequate clearance around a utility box, the removal of existing pine trees, and the use of date palms in the plaza landscape plan. He also brought up concerns related to lighting. He recommended the design of the proposed lampposts match the style of existing street lampposts.

## AR-2 SIGN2022-0017 Sign Review; 1333 South Mayflower Avenue, Cogent Signs, Applicant

The Committee discussed various aspects of the application and asked additional questions of staff.
