The applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants. Additionally, written comments submitted prior to the start of the meeting will be presented to the Committee as part of the consideration of the request. AR-1 [SIGN2023-0003 Sign Review; 674 West Huntington Drive, Gregory Diaz, Applicant](#)

**Request:** Applicant is requesting a sign review for a new illuminated, individual channel letter building wall sign and a new projecting sidewalk sign for an existing business, "The Joint Chiropractic." This property is located in the CRS (Commercial Regional/Subregional) zone. Determine that the project is Categorically Exempt (Class 11) pursuant to the California Environmental Quality Act (CEQA).

AR-2 **MISC2023-0001 Miscellaneous Review; 1320 California Avenue, Gil Mars for Bowden Development, Inc., Applicant**

**Request:** Applicant is requesting a waiver of the underground utilities requirement set forth in Monrovia Municipal Code §15.30.040 in order to avoid creating a safety hazard due to the installation of an additional electrical conduit on an existing utility pole. **Request:** Applicant is requesting a review to change the hours of operation for an existing business "Sena on Myrtle." The applicant is requesting to modify their indoor dining operating hours from 6:00 AM to 12:00 AM midnight, seven days a week to 6:00 AM to 2:00 AM, seven days a week. Approval of the Miscellaneous Review would allow amendment of the Condition of Approval #22 in CUP2010-04 (Conditional Use Permit 2010-04). This property is located in the HCD (Historic Commercial Downtown) zone.
