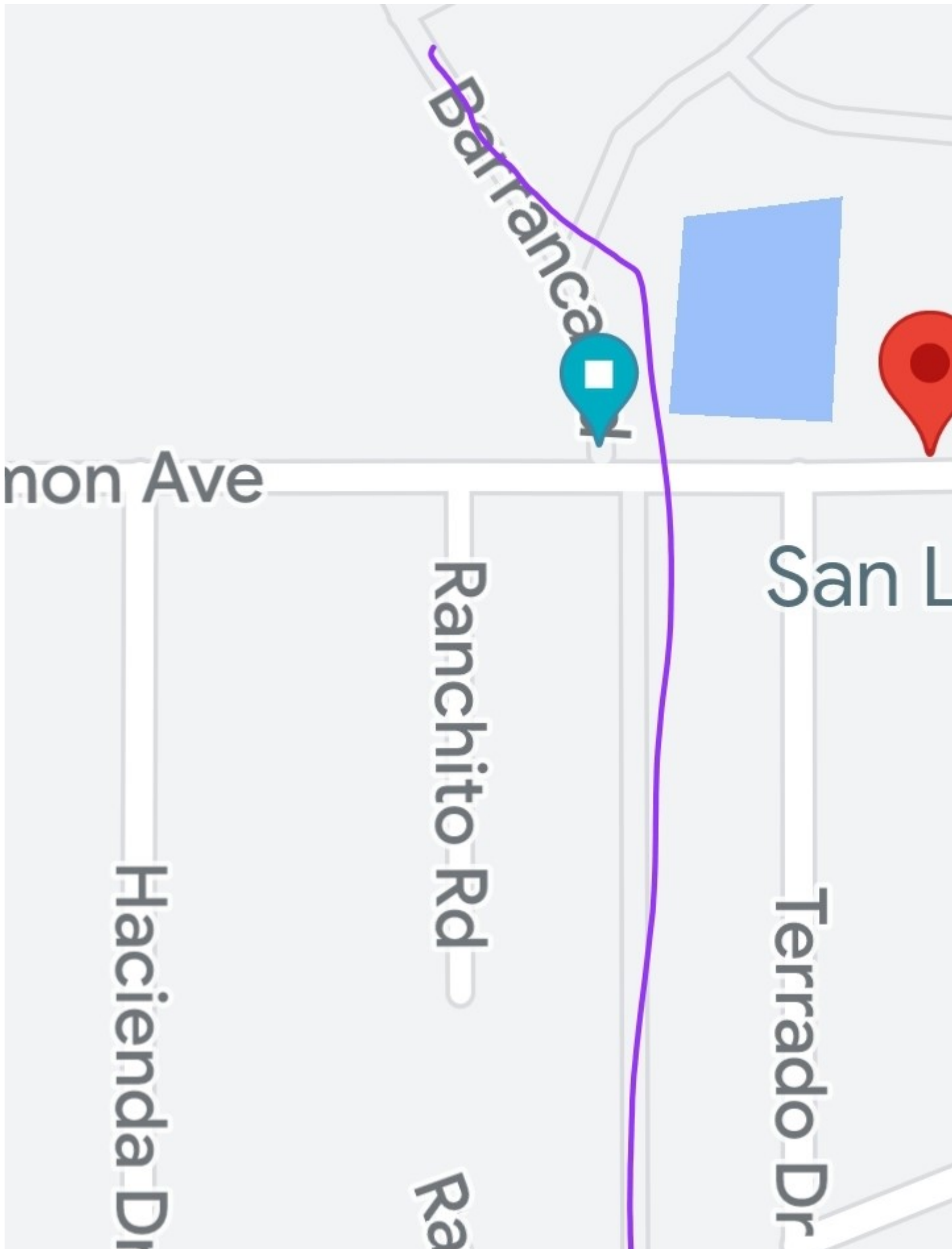

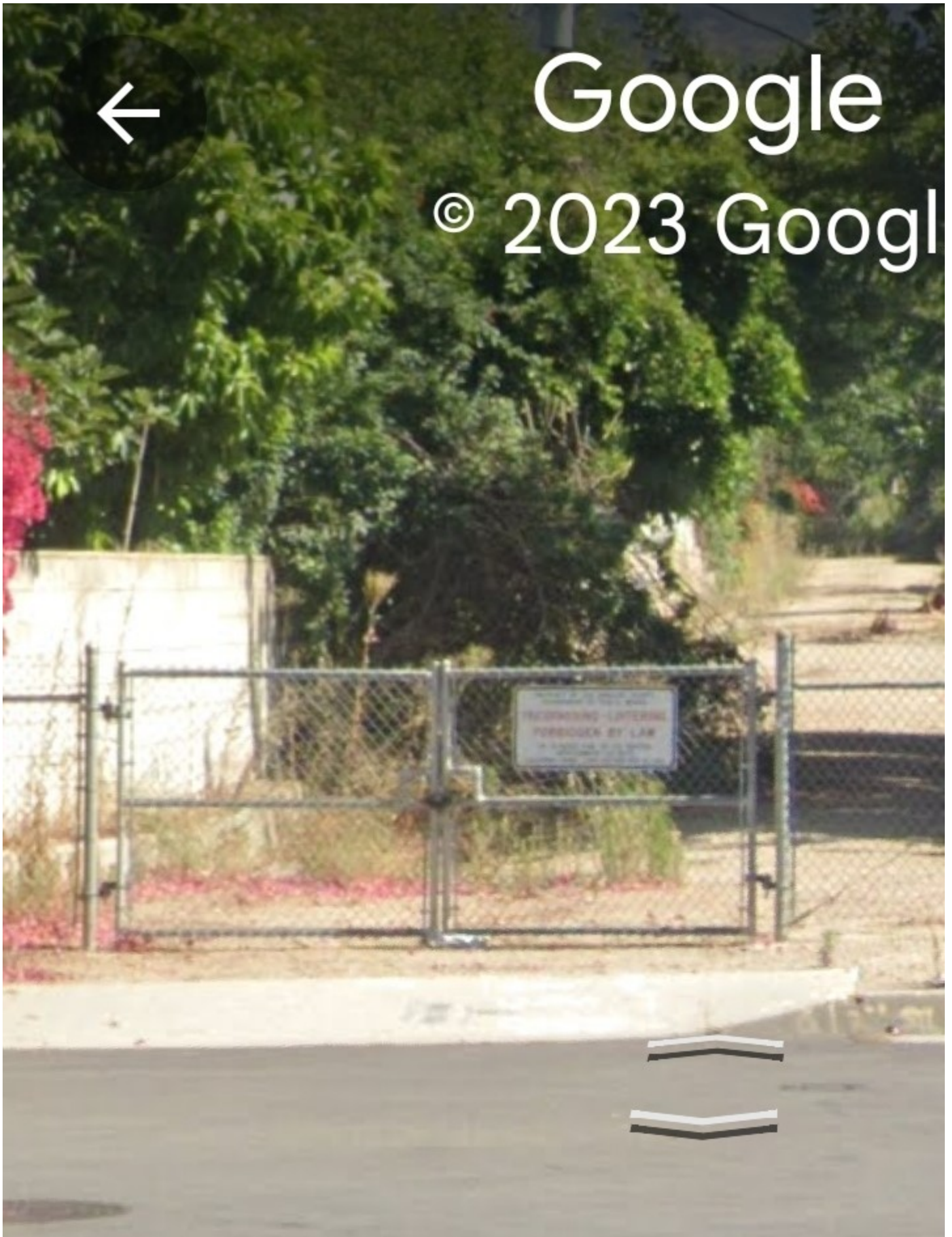

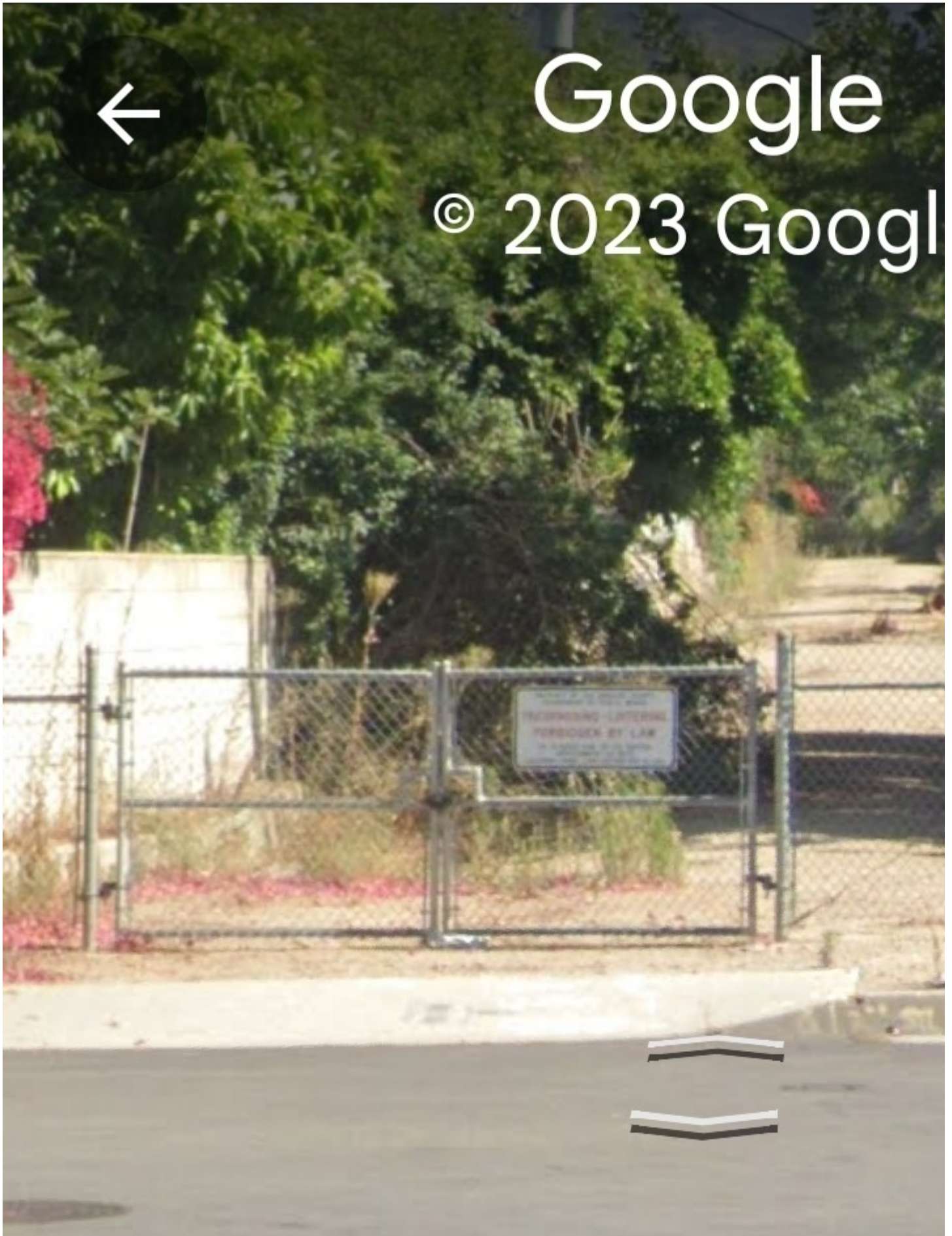

Dear Councilmembers,

I wanted to give a quick shout out to new public works director Alex Tachiki. At the March 21, 2023 City Council meeting, Theresa brought the low hanging low voltage wire across the Sawpit Wash trail that was creating a choking hazard to the attention of the Council. I also had reported that to Frontier last Fall with no action. Alex took the ball on that and the wire was raised to a safe height within a week.

At the same meeting, Mayor Shevlin raised a situation with a major pothole on the onramp to the westbound 210 near the Lowes Outlet. Alex escalated with Caltrans and that area was repaired soon after.

Mount Sierra College closed over 4 years ago. About a year ago, I submitted a request to Caltrans to have their sign removed from the eastbound 210 just before the Mountain exit. Caltrans created a ticket and even sent me an email saying that it would be scheduled but of course nothing happened. At the April 4, 2023 City Council meeting, I spoke with Alex and asked him to follow up. Within a week the sign was gone.

While I wish agencies would just respond to ordinary residents, it is very nice to know that Alex knows the hot line numbers, escalation passwords and secret handshakes. Thanks again to Alex for getting these issues resolved and congratulations on the promotion.
